TERMINATION AND RELEASE OF NONDISTURBANCE, ATTORNMENT AND SUBORDINATION AGREEMENT

THIS TERMINATION AND RELEASE OF NONDISTURBANCE, ATTORNMENT AND SUBORDINATION AGREEMENT ("Termination Agreement") is made and entered into on the 2 day of July, 2012, by and between WELLS FARGO AND COMPANY f/k/a Wachevia Bank, National Association ("Lender") and BUILDERS FIRST SOURCE - SOUTHEAST GROUP, INC., a Delaware corporation ("Tenant").

WITNESSETH:

WHEREAS, Wachovia Bank, National Association and Tenant previously entered into that certain Nondisturbance, Attornment and Subordination Agreement dated December 20, 2007, and recorded as Instrument No. 20071227000578720, Shelby County, Judge of Probate, Alabama records (the "NDA") relating to a Lease dated December 20, 2007 (the "Lease") between The Manis Family Limited Partnership, as landlord ("Landlord") and Tenant;

WHEREAS, Lender is the successor in interest to Wachovia Bank, National Association;

WHEREAS, in light of the purchase of the real property which is the subject of the Lease, and the termination of the Lease, Lender and Tenant desire to terminate, release and cancel the NDA.

NOW, THEREFORE, in consideration of the premises, the mutual covenants and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1. Termination, Release and Cancellation of the NDA. Lender and Tenant hereby jointly terminate, release, cancel and discharge the NDA in its entirety, and declare that the same be deemed null, void and of no further force or effect, effective as of the date of this Agreement. Lender and Tenant each hereby releases the other, together with their past or present officers, directors, employees, agents, attorneys, insurers, affiliated companies, successors and assigns from any and all obligations under the NDA and agree to waive any action in connection thereto.
- 2. <u>Direction to Clerk of Court</u>. The Clerk of the Shelby County, Alabama Judge of Probate office is hereby directed to mark the NDA as terminated and canceled in the records of the Shelby County, Alabama Judge of Probate office.
- 3. <u>Authority</u>. Each person executing this Termination Agreement on behalf of a party represents and warrants to the other party that such person is duly authorized to execute this instrument on behalf of such party.
- 4. <u>Entire Agreement</u>. This Termination Agreement represents the entire understanding and agreement of the parties hereto with respect to the subject matter hereof, and supersedes all other negotiations, understandings and representations (if any) made by and between such parties.
- 5. <u>Binding Effect</u>. All of the terms and conditions of this Termination Agreement, whether so expressed or not, shall be binding upon, inure to the benefit of, and be enforceable by the parties hereto and their respective legal representatives, successors and assigns.
- 6. <u>Counterparts</u>. This Termination Agreement may be executed inn a number of identical counterparts, each of which for all purposes is deemed an original, and all of which constitute collectively one (1) agreement, but in making proof of this Termination Agreement, it shall not be necessary to produce or account for more than one such counterpart.




