Greer, a widowed man, (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, Ray E. Greer, a widowed man, Stephen Ray Greer, a married man, Arleen Elizabeth Gilliland, a married woman, and Sharon Elaine Greer, a married woman (hereinafter referred to as Grantees),), for and during their joint lives and upon the death of one of them, then to the other survivors of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

LEGAL DESCRIPTION

A parcel of land lying within the boundaries of the SE 1/4 of the NW 1/4 of Section 2, Township 24 North, Range 12 East, more particularly described as follows:


