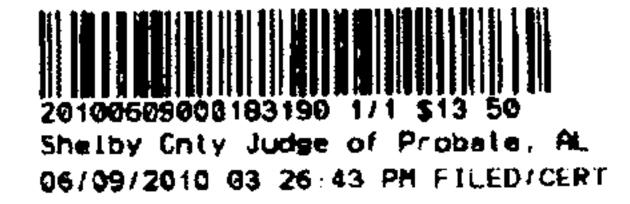

Nicholson, deceased, Probate Case No. 17-045 (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto John Lee Holm and Robyn Ashley Holm as joint tenants with rights of survivorship (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama:
