


## Revocation of the Bedsole-Kerschner Trust Agreement



# Declaration of Trust

## MEMORANDUM OF AGREEMENT BEDSOLE-KERSCHNER TRUST

The following constitutes a MEMORANDUM OF TRUST referencing the BEDSOLE-KERSCHNER TRUST AGREEMENT.

We, WILLIAM STEVEN BEDSOLE and JANET KERSCHNER BEDSOLE, are Joint Grantors under a revocable living trust agreement wherein we are designated as Joint Trustees. We have conveyed ownership of various assets to our trustees to be held in trust. Joint Grantors' right of revocation is unrestricted and includes the right of amendment and the right to withdraw assets.

including real property, if any, comprising the trust estate,  
in any manner on such terms as trustee shall determine.
