**ARTICLE FOUR**

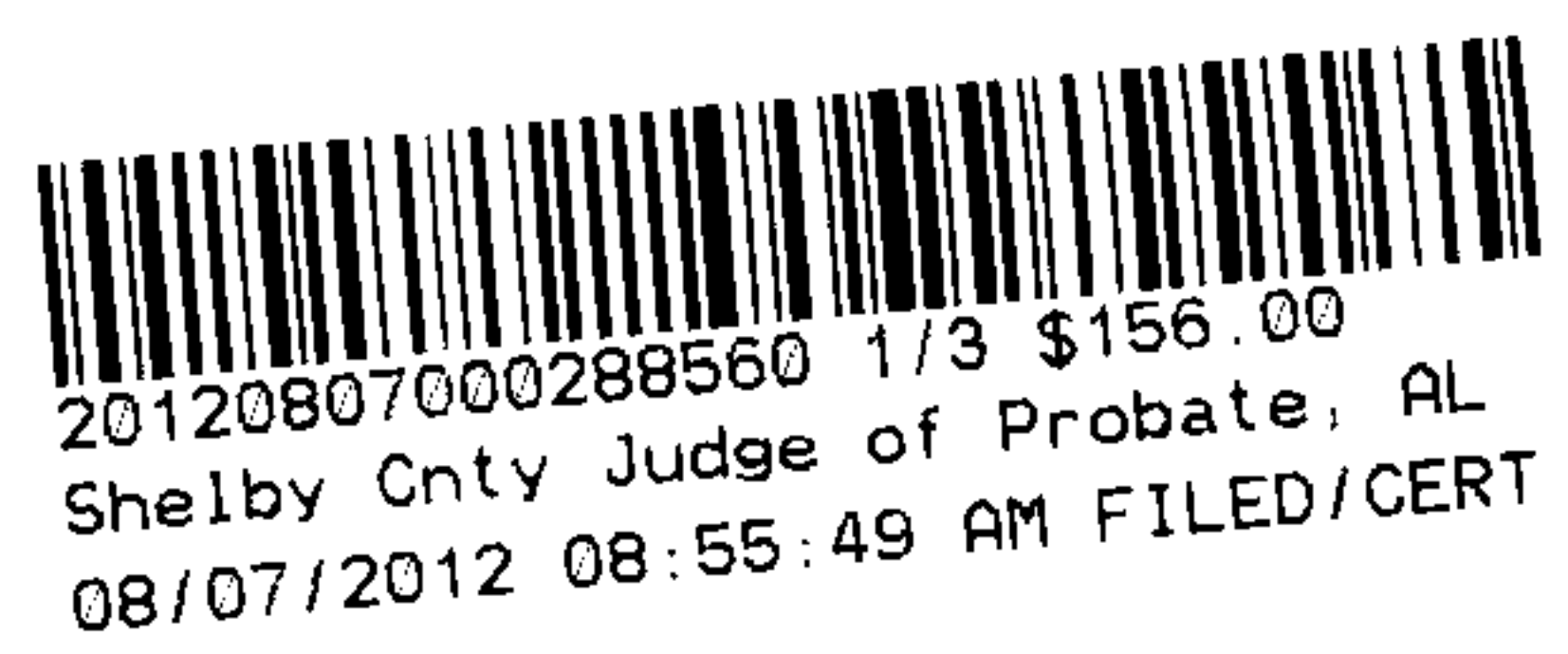
The name and business address of the limited liability company's registered agent for service of process is Robert F. King, 9360 Old Hwy. 280, Chelsea, Alabama, 35043.

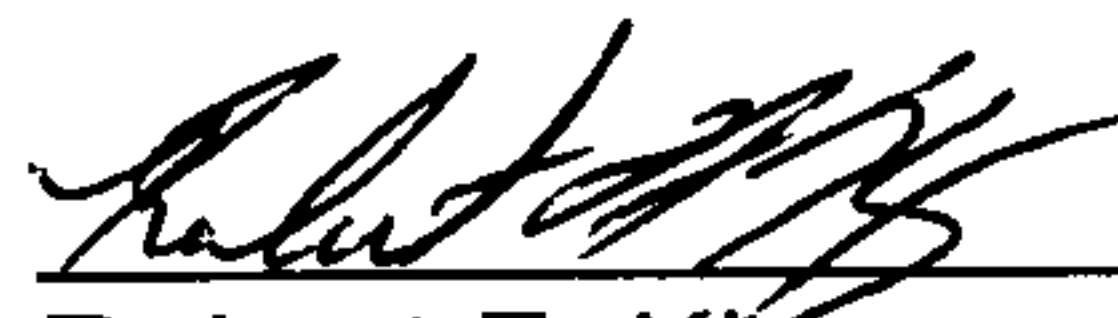
## ARTICLE EIGHT

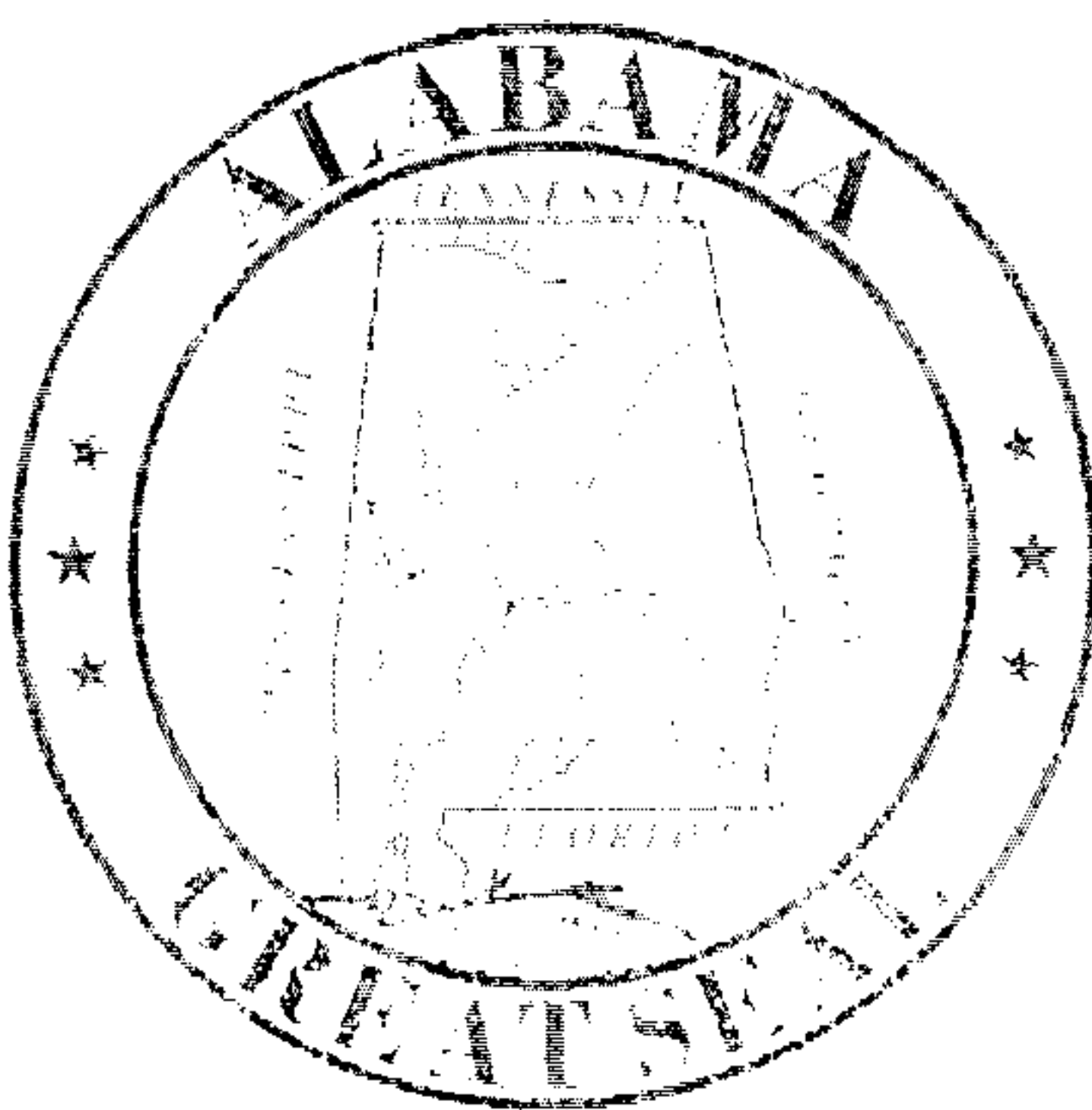
