Know All Men by These Presents: That in consideration of **Two hundred eighty nine thousand nine hundred and no/100 (\$289,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **DAL Properties, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **John M. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

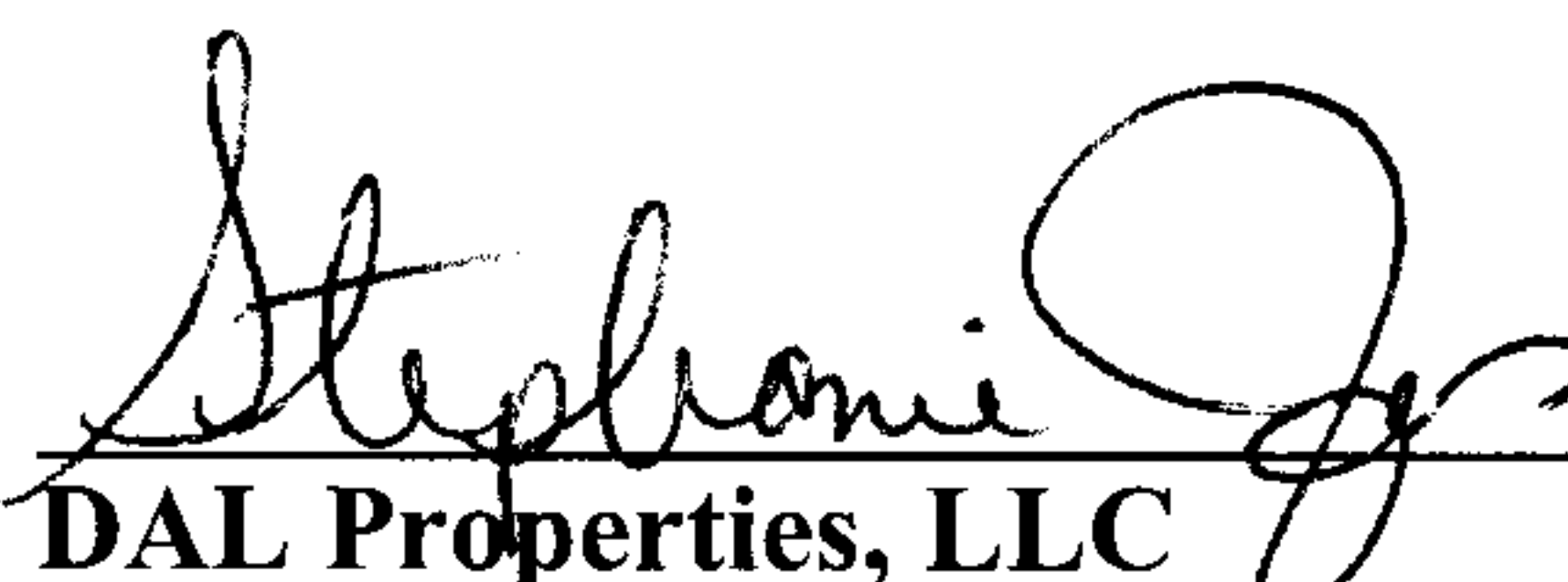
\$231,920.00 of the purchase price recited above was paid from a purchase money mortgage loan closed simultaneously herewith.
