Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

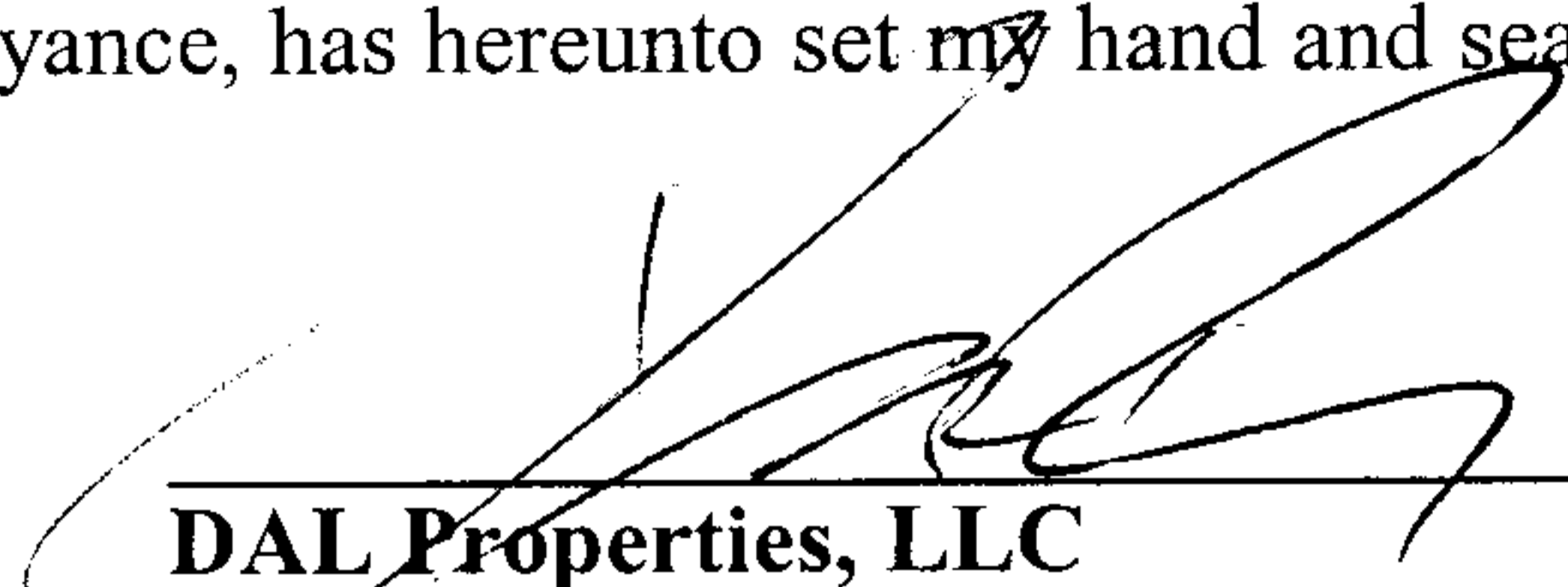
\$245,005.00 of the purchase price recited above was paid from a purchase money mortgage loan closed simultaneously herewith.
