1. The trailer and or house is to be kept for my daughters, Rebekah Dawn Carver and Bailey Marie Carver, for them to share equally.
 2. My possessions are to be returned to the child that gave them to me. My possessions given to me by my wife are to be divided between Rebekah Dawn Carver and Bailey Marie Carver. All my other possessions are to be divided equally between Tina Denise Carver Bryant, Rebekah Dawn Carver and Bailey Marie Carver.
 3. My life insurance after my burial expenses is to be divided equally between Rebekah Dawn Carver and Bailey Marie Carver.
