THIS AGREEMENT is made and entered into on this 23rd day of July, 2012, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of MERS, INC., AS NOMINEE FOR QUICKEN LOANS INC., its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions Bank loaned to Angela A Houston and Greg H Houston (the "Borrower", whether one or more) the sum of \$31,700.00. Such loan is evidenced by a note dated October 20, 2011, executed by Borrower in favor of Regions Bank, which note is secured by a mortgage, deed of trust, security deed, to secure debt, or other security agreement recorded 11/7/2011, Instrument # 20111107000335350 in the public records of SHELBY COUNTY, AL (the "Regions Mortgage"). 

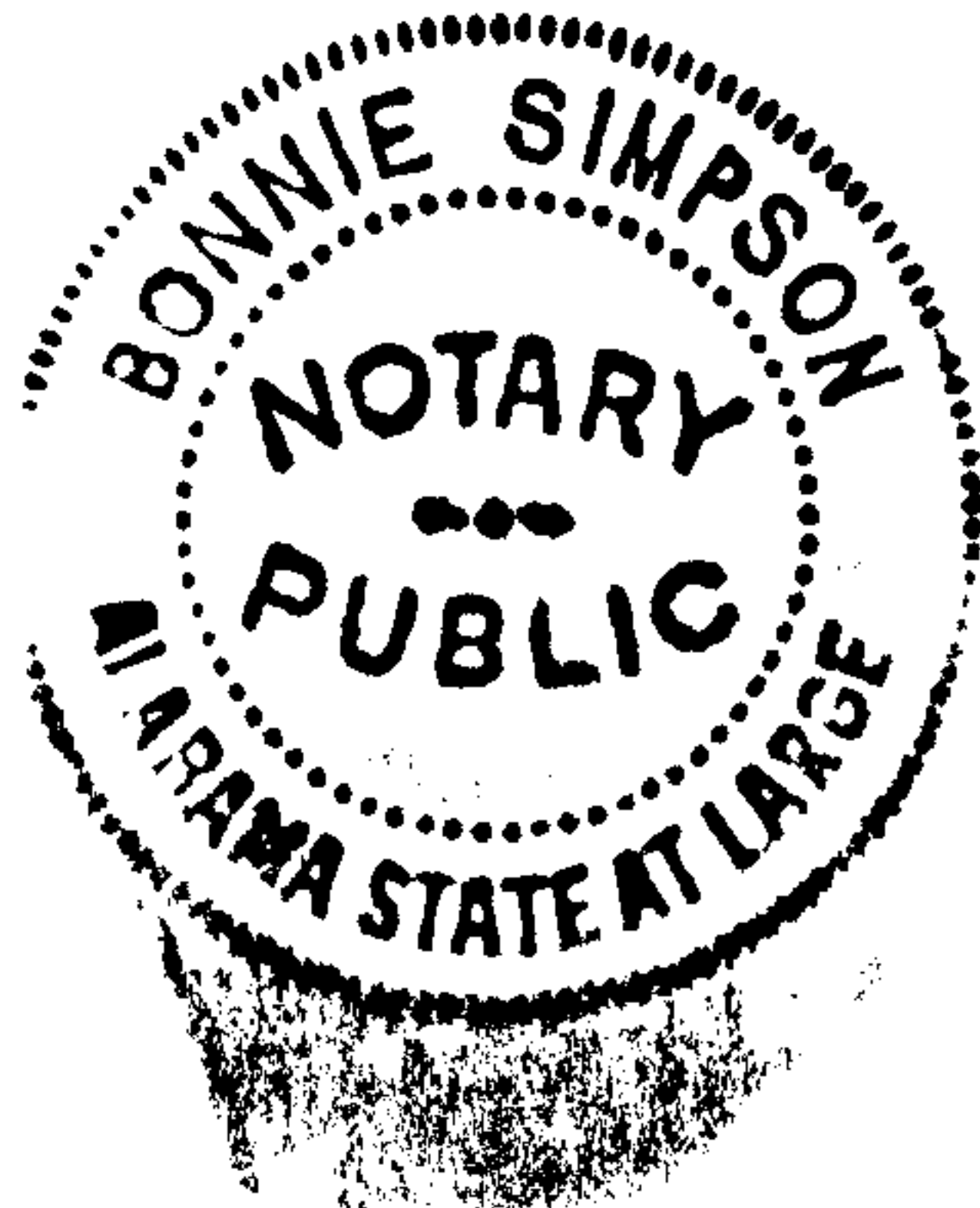
