

DOMESTIC LIMITED LIABILITY COMPANY
ARTICLES OF IRONSHORE INTERIORS, L.L.C.

Pursuant to the provisions of the *Alabama Limited Liability Company Act*, §10-12-1 et. seq., *Code of Alabama* (1975), as amended, the undersigned hereby adopts the following Articles of Organization:

ARTICLE I

The name of the Limited Liability Company shall be: **IRONSHORE INTERIORS, L.L.C.**

ARTICLE II

The period of duration shall be: **Fifty (50) years from and after the date of the formation of the Limited Liability Company unless the Limited Liability Company is earlier dissolved in accordance with either the provisions of the operating agreement or of the Alabama Limited Liability Company Act.**

The Limited Liability Company has been organized for the following purposes:

- A) providing interior decorating services; and,**
- B) any other lawful purpose or purposes.**

The location and street address of the initial registered office shall be:

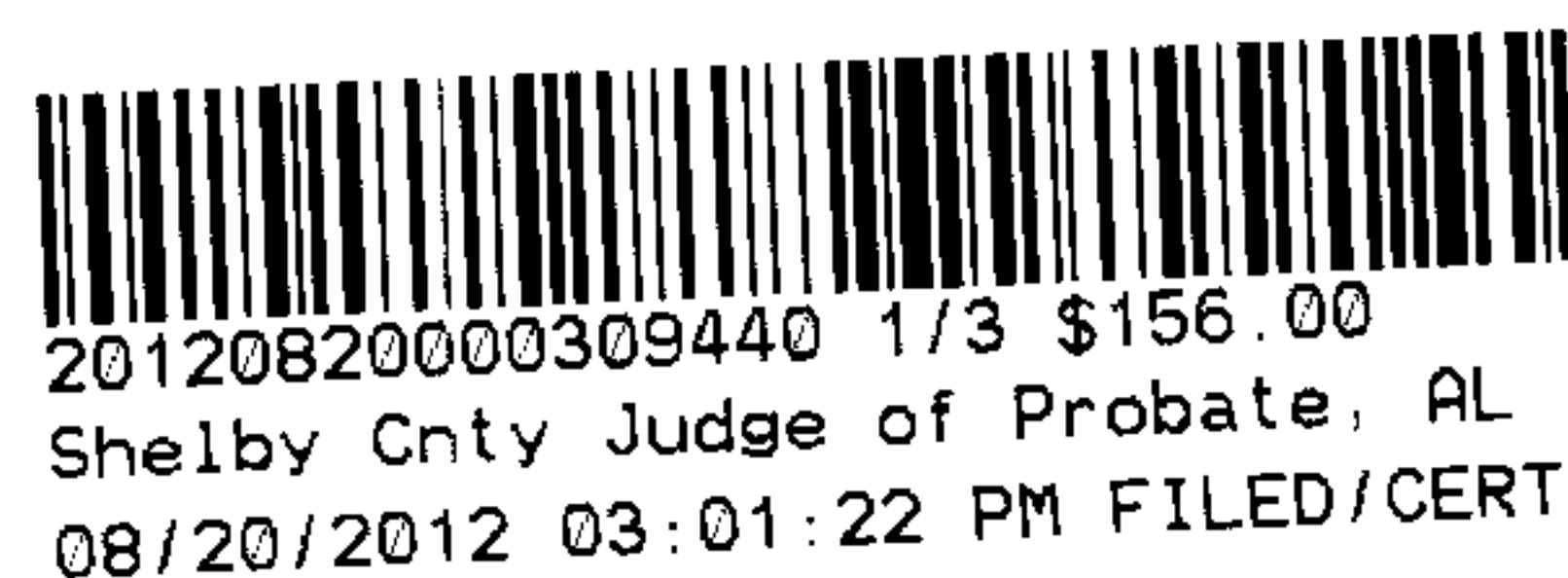

ARTICLE VII

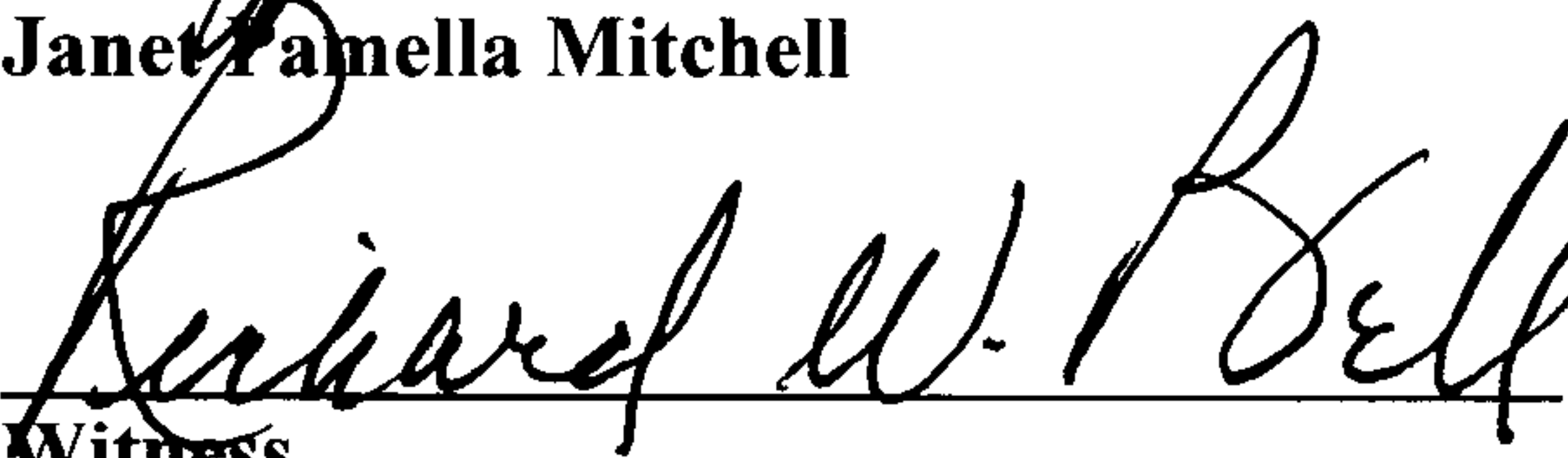
The Limited Liability Company shall be managed by its Members.

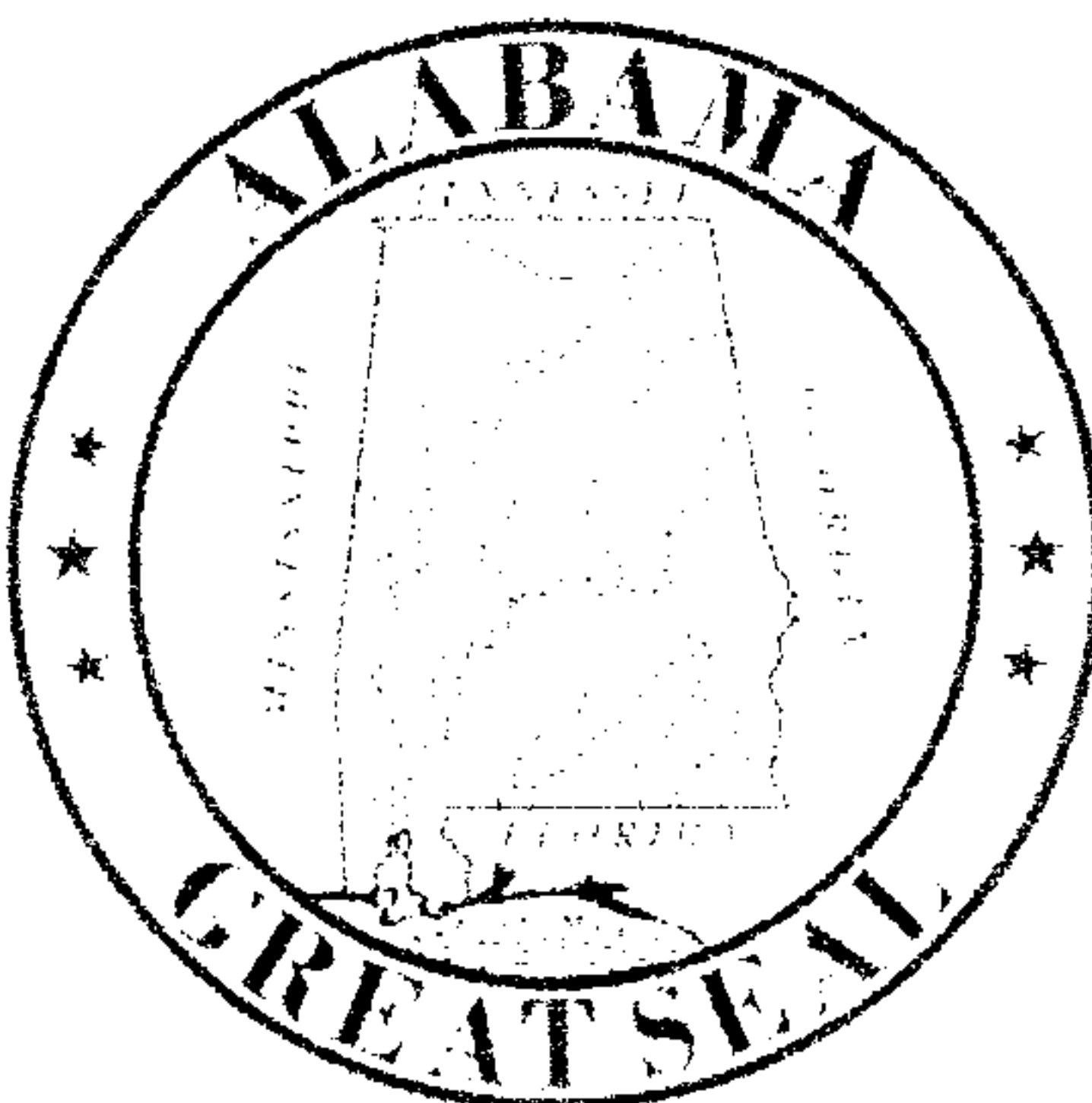
