

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on May 21, 2004, to-wit: James R. Pope, an unmarried man, executed a mortgage to Mortgage Electronic Registration Systems, Inc. as nominee for CTX Mortgage Company, LLC, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on the June 1, 2004, in Instrument Number 20040601000290470, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association successor by merger to Chase Home Finance LLC, by assignment recorded April 18, 2012, in Instrument Number 20120608000203110, Probate Records of Shelby County, Alabama; and

WHEREAS, the said mortgage provides that if said indebtedness or any part thereof should remain unpaid at maturity, then the whole of indebtedness shall at once become due and payable and said mortgage be subject to foreclosure, and further provides that in the event of any such default the Mortgagee or its assigns shall have the authority to sell said property before the Courthouse door in the City of Columbiana, County of Shelby, State of Alabama, at public outcry for cash after first giving notice by publication once a week for three successive weeks of the time, place and terms of said sale in some newspaper of general circulation published in Shelby County, Alabama, and further provides that in the event of any such sale the person conducting such sale shall have power and authority to execute a deed to the purchaser of said property at such sale, and further provides that the Mortgagee or its assigns may bid and become the purchaser at such sale of the property therein; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on June 27, 2012, July 4, 2012, and July 11, 2012, that the hereinafter described property would be sold before the front door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on August 7, 2012, and

WHEREAS, the said sale was held at the time and place stated in said notice, in strict conformity with the powers of sale contained in the said mortgage, at which sale FEDERAL NATIONAL MORTGAGE ASSOCIATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA, became the purchaser of the hereinafter described property at and for the sum of \$204,679.58, cash, which was the highest, best, and last bid therefore; and

WHEREAS, the undersigned, James J. Odom, Jr., conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by JPMorgan Chase Bank, National Association successor by merger to Chase Home Finance LLC;

NOW THEREFORE, IN consideration of the premises James R. Pope, an unmarried man, and JPMorgan Chase Bank, National Association successor by merger to Chase Home Finance LLC, both acting by and through the undersigned as their duly constituted and appointed attorney-in-fact and auctioneer at said sale, do hereby grant, bargain, sell and convey unto the said FEDERAL NATIONAL MORTGAGE ASSOCIATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA the following described real property situated in Shelby County, Alabama, at 113 Lane Park Dr., Maylene, AL 35114, but in the event of a discrepancy, the legal description shall control to-wit:

Lot 518, according to the Survey of Grande View Estates, Givianpour Addition to Alabaster, 5th Sector, as recorded in Map Book 21, Page 133, in the Probate Office of Shelby County, Alabama.
