Know All Men by These Presents: That in consideration of **One hundred seventy four thousand nine hundred and no/100 (\$174,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Acton Land Company, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Willie F. 
