

\$96,632.83 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to:

- (1) 2012 ad valorem taxes not yet due and payable;
- (2) all mineral and mining rights not owned by the Grantor; and
- (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


