FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of September, 2002, S. Thomas Payne and Cynthia R. Payne, husband and wife, executed that certain mortgage on real property hereinafter described to Ameriquest Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20021002000476880, said mortgage having subsequently been transferred and assigned to JPMC Specialty Mortgage LLC, by instrument recorded in Instrument Number 20090108000005990, in the aforesaid Probate Office ("Transferee"); and

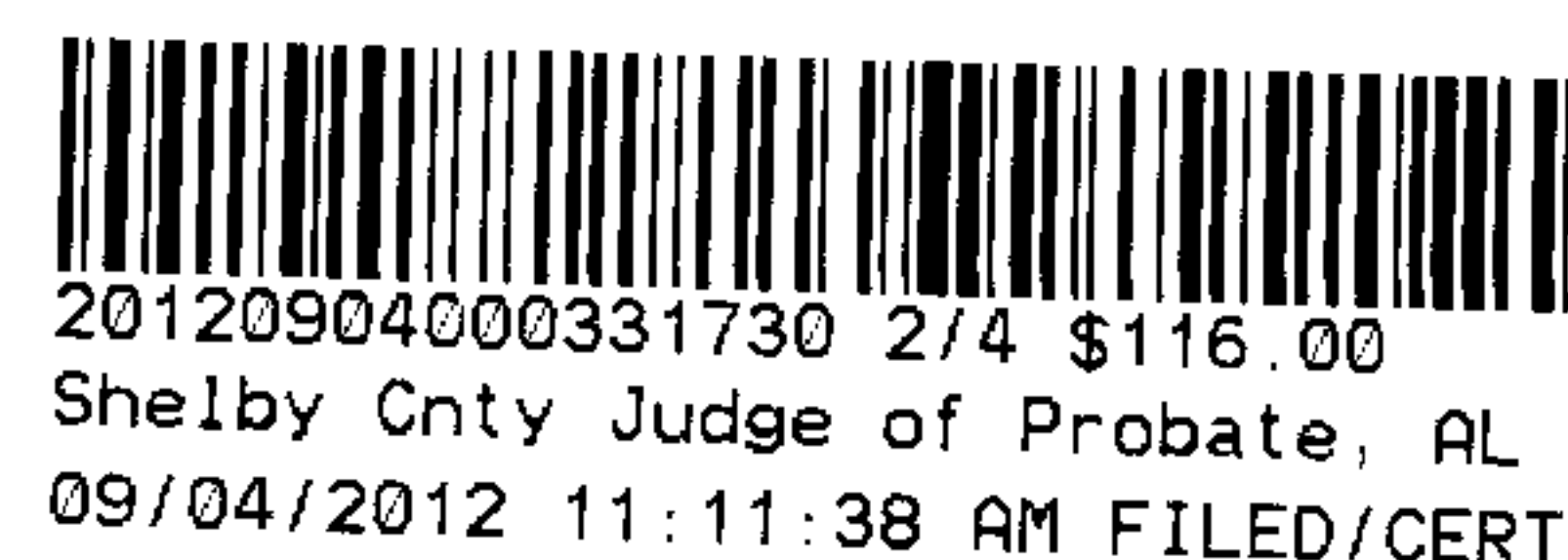
