WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Sixty-Five Thousand And No/100 Dollars (\$265,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Jeffrey Schwieker and Lindsey Schwieker, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Jesse S. Kelly and Stephanie A. Kelly (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Jefferson County, Alabama.
