1. Grant of Easement to Access Easement Property. Grantors do hereby grant to Grantee and her respective heirs, executors, administrators, personal representatives, successors and assigns, forever, a non-exclusive easement over, across, through and upon the Access Easement Property for the purposes of providing vehicular and pedestrian access to and from the Fishburne Property.

2. Miscellaneous.

(a) This Agreement embodies the entire agreement between the parties hereto with respect to the subject matter hereof and supersedes all prior written or oral agreements and undertakings of the parties relating to the subject matter of this Agreement. This Agreement may be modified, amended or supplemented only by an instrument in writing executed by the then record owners of the Access Easement Property and the Fishburne Property.


