KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of April, 2007, Jack M. Knight, Jr. and Vicki W. Knight, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Wachovia Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070419000182140, said mortgage having subsequently been transferred and assigned to JPMorgan Chase Bank, National Association successor by merger to Chase Home Finance LLC, by instrument recorded in Instrument Number 20100818000265310 and corrected in Instrument Number 20120614000210450, in the aforesaid Probate Office ("Transferee"); and

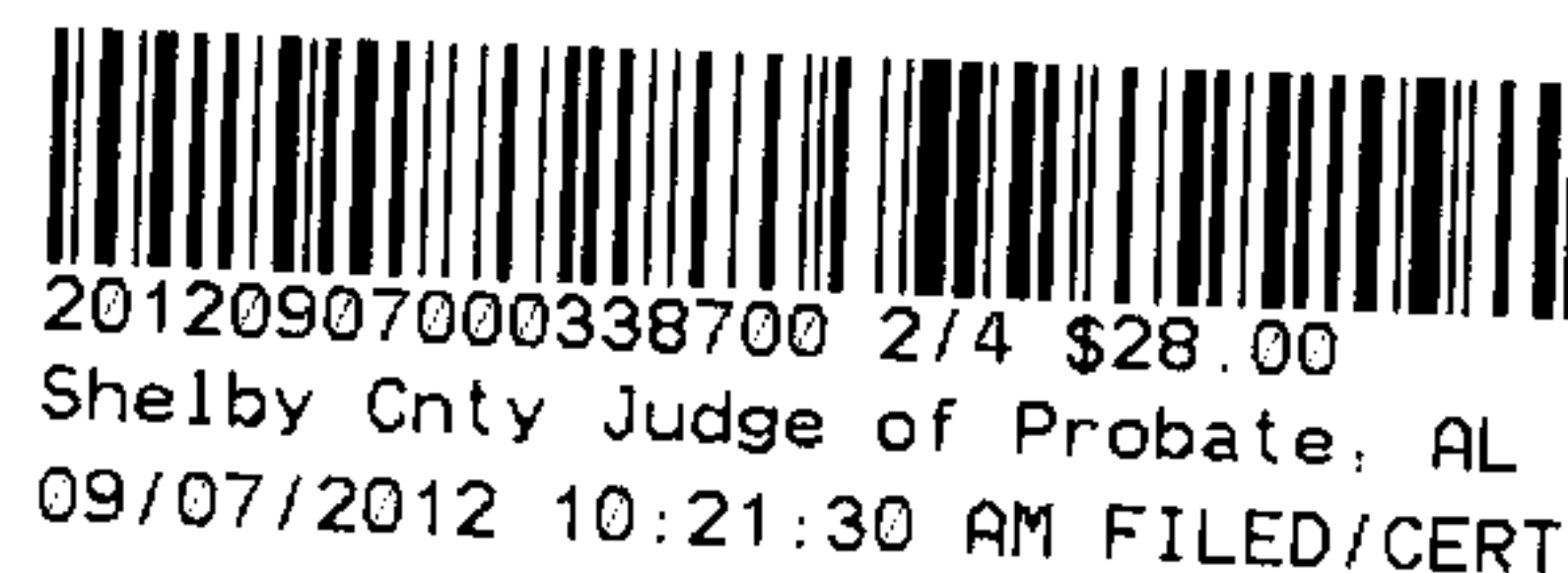

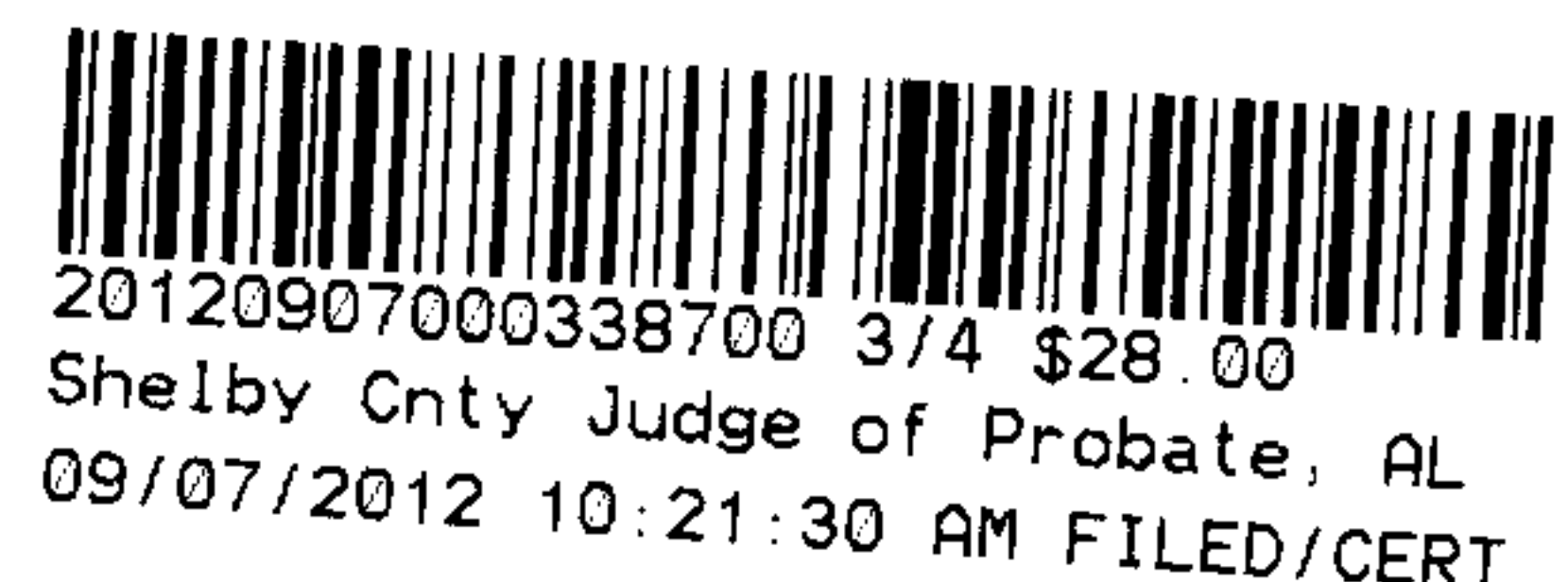
