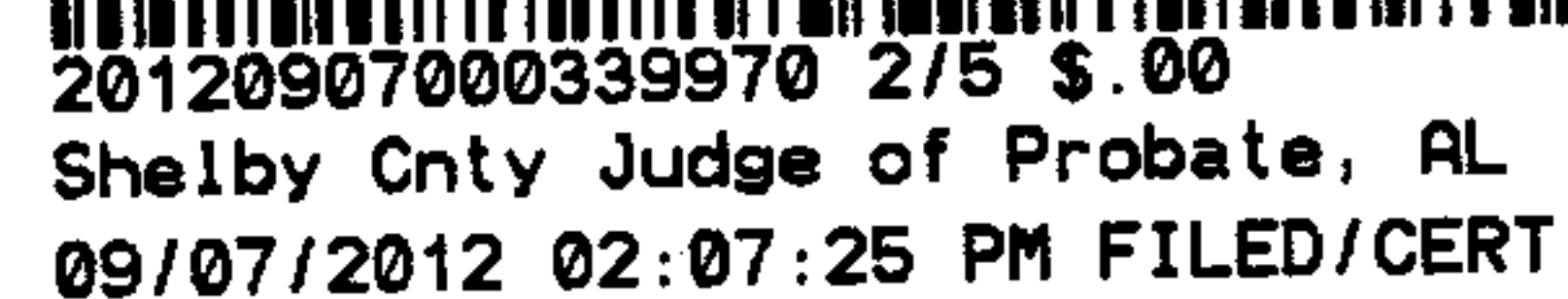

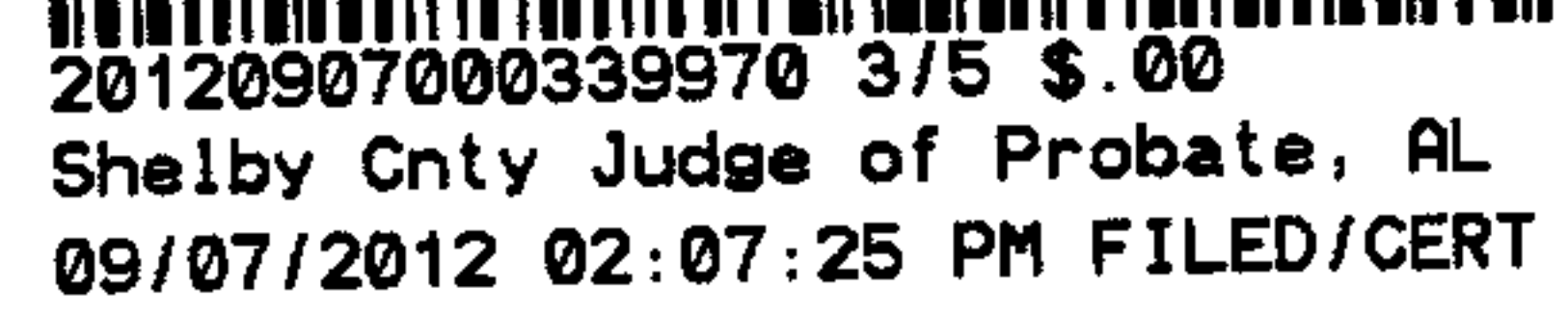


FORM 2: Contributions received by political action committee

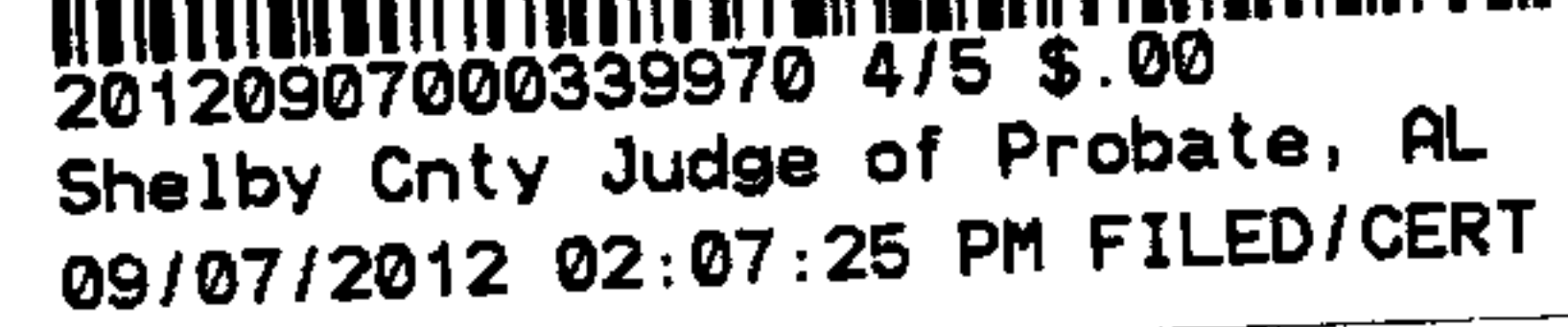

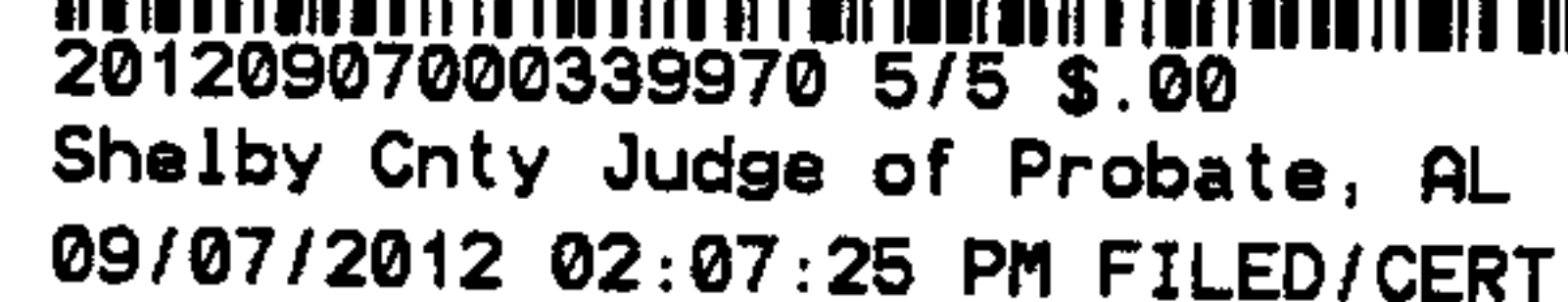
