KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of January, 2008, Timothy L. Stomps and Amie B. Stomps, husband and wife, and Nancy K. 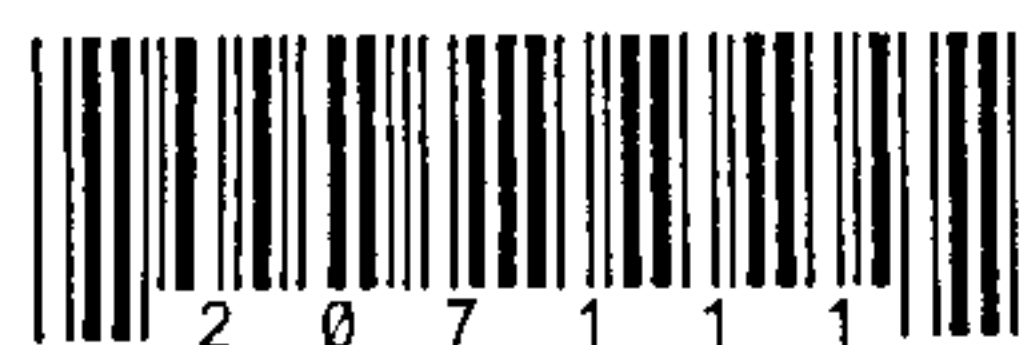
