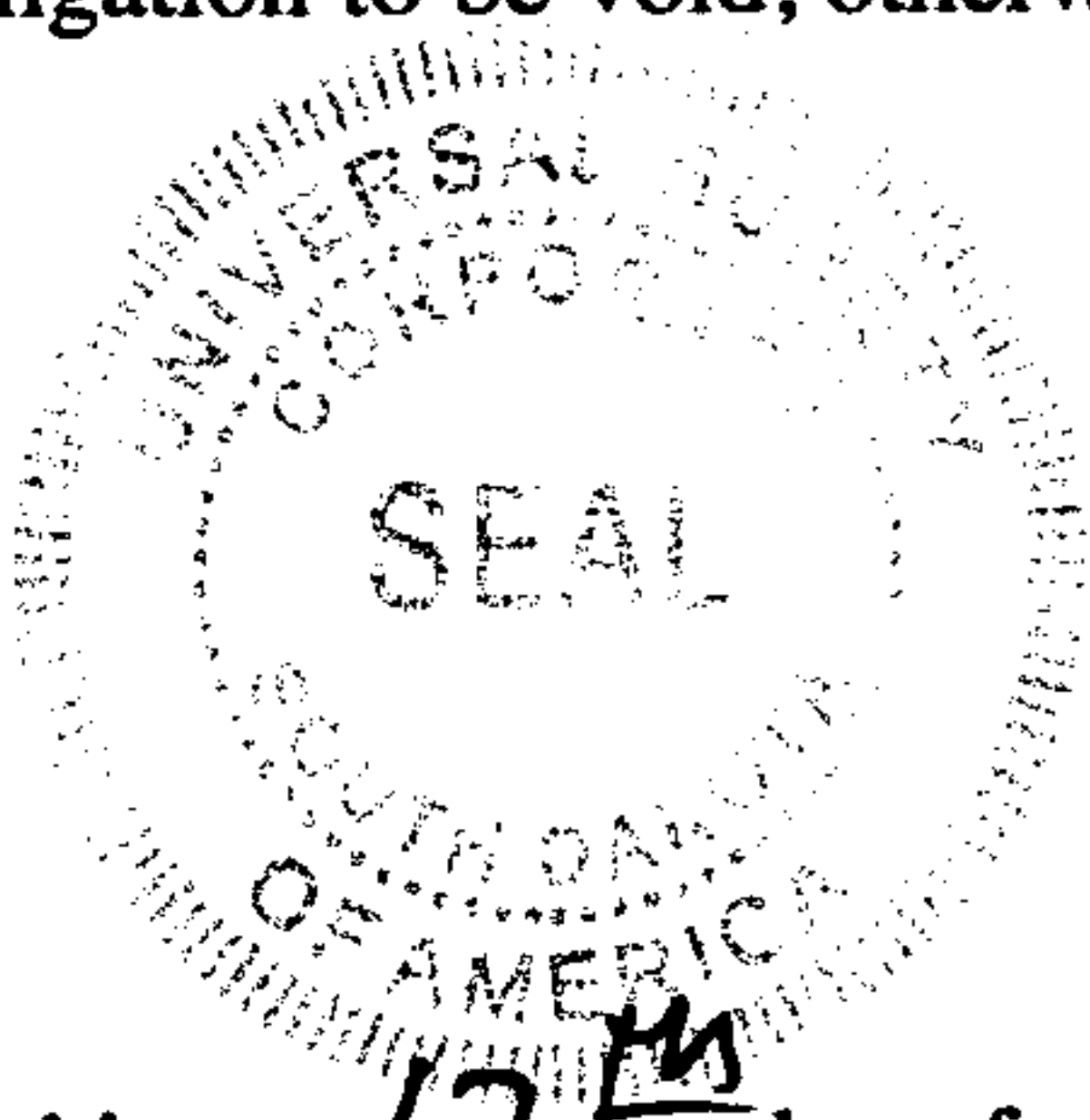
KNOW ALL PERSONS BY THESE PRESENTS:

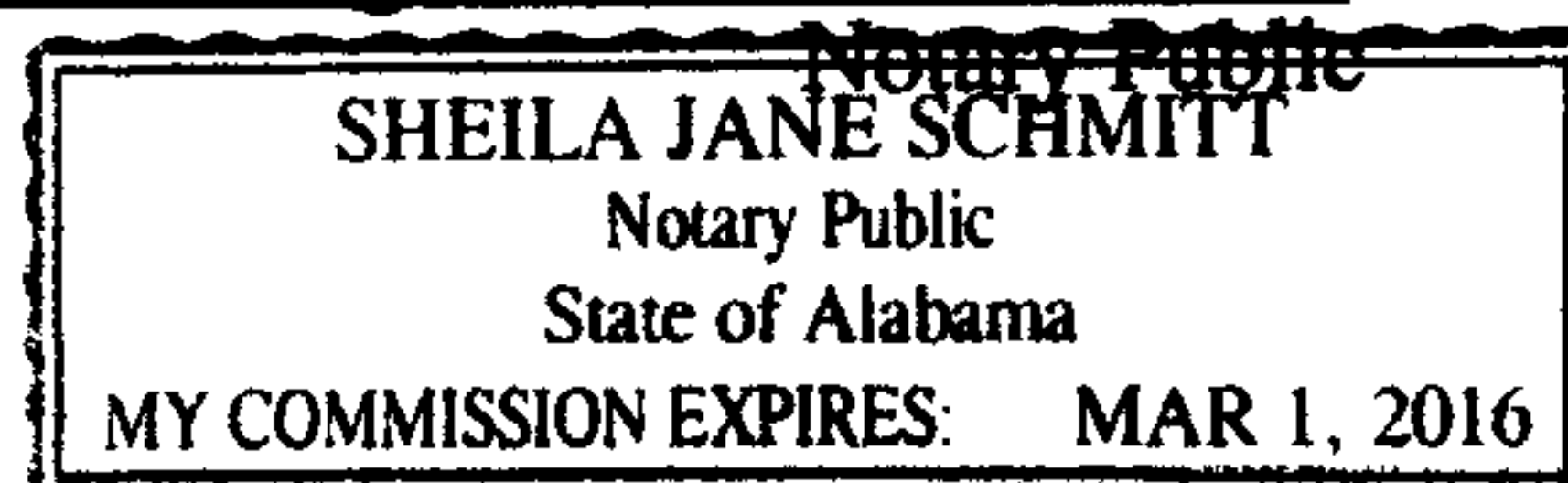
### Oath of Office

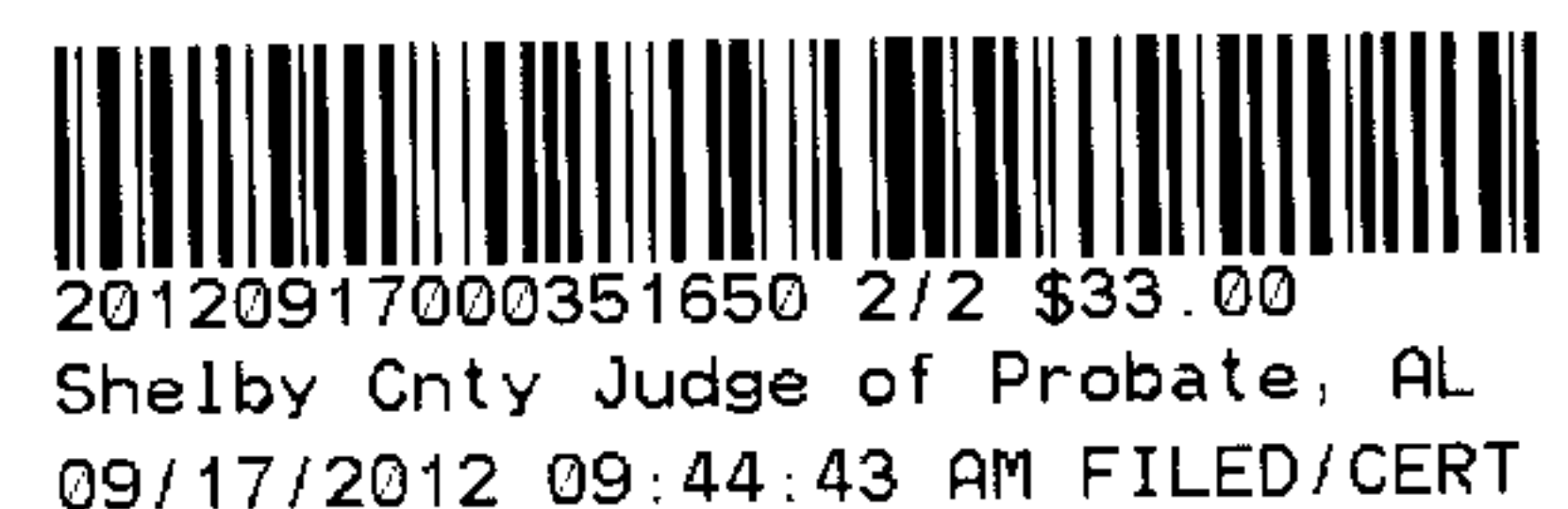

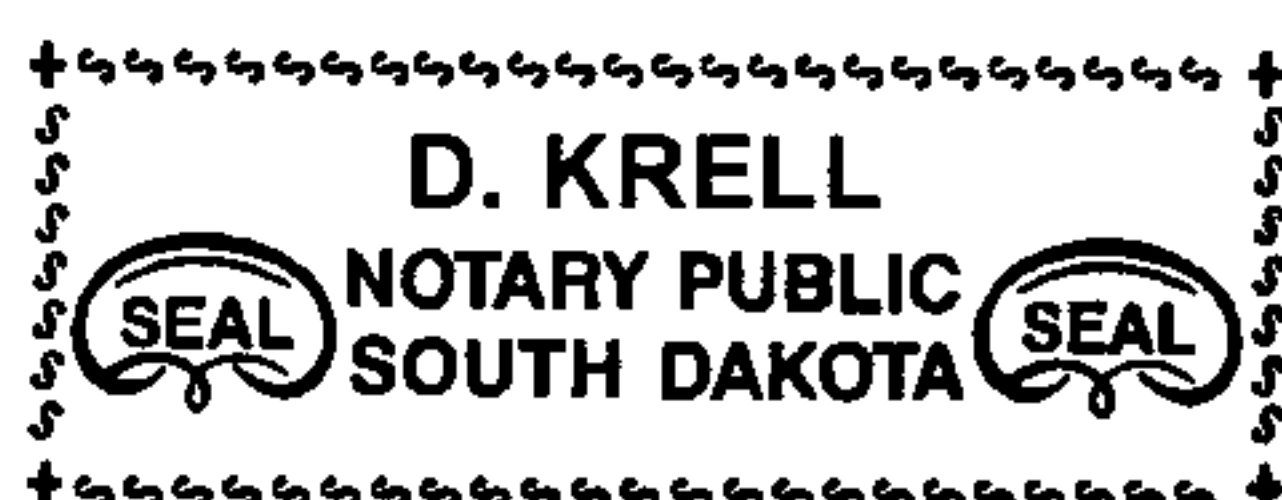
