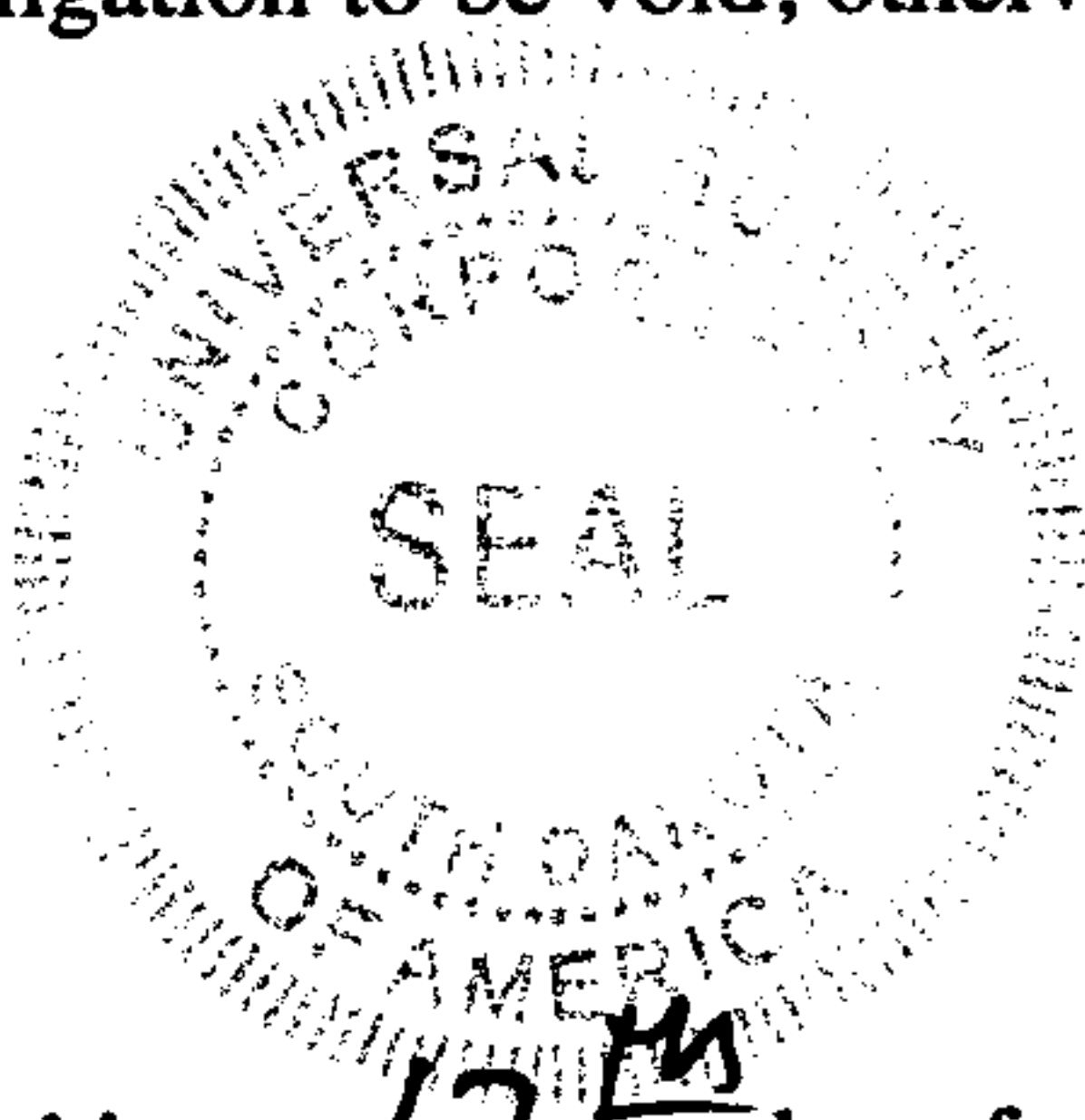
KNOW ALL PERSONS BY THESE PRESENTS:

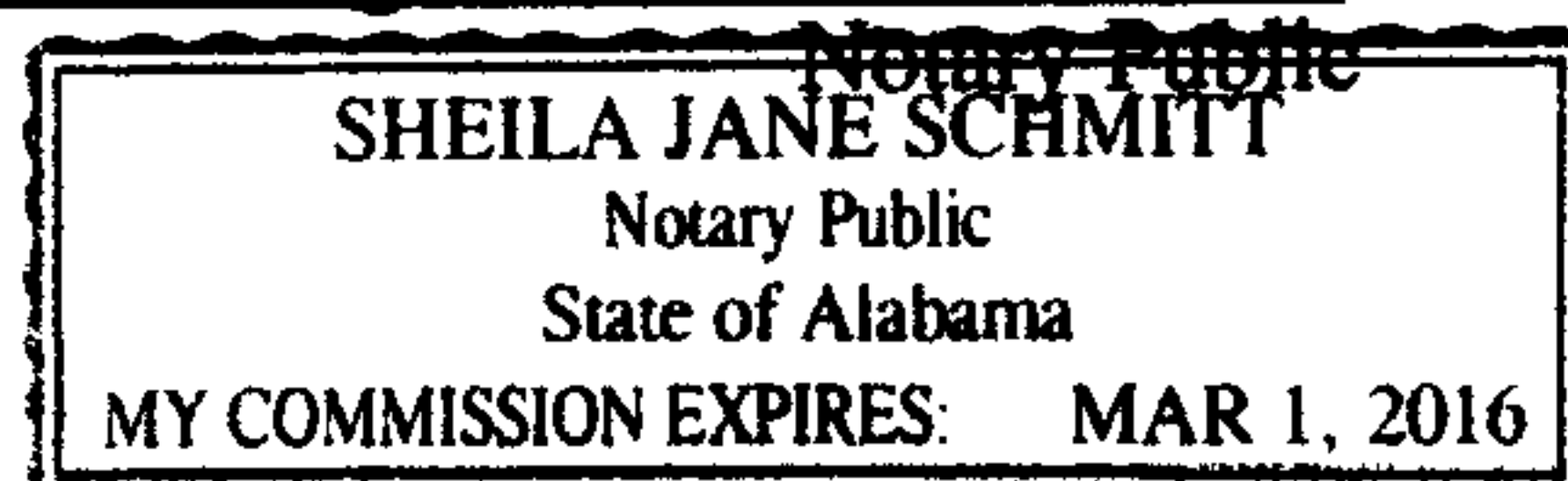
Oath of Office

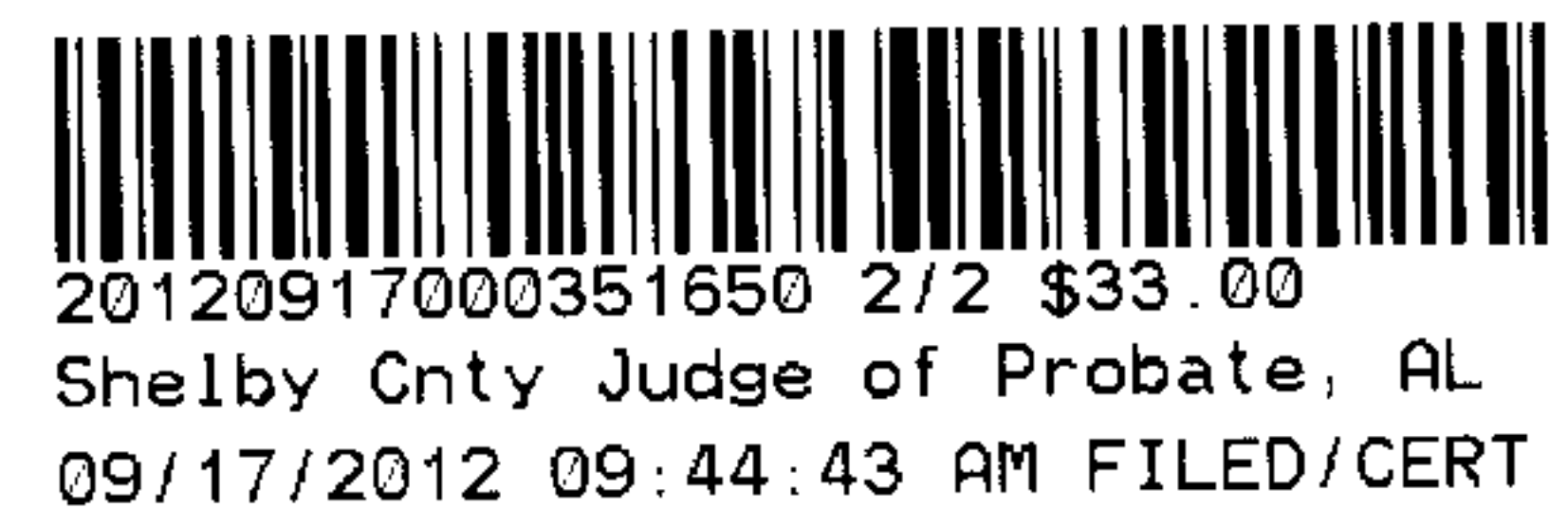
