KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of June, 2007, Celso Cervantes, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Advance Mortgage & Investment Co. of North FL Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20070706000319020, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument Number 20120731000276860, in the aforesaid Probate Office ("Transferee"); and

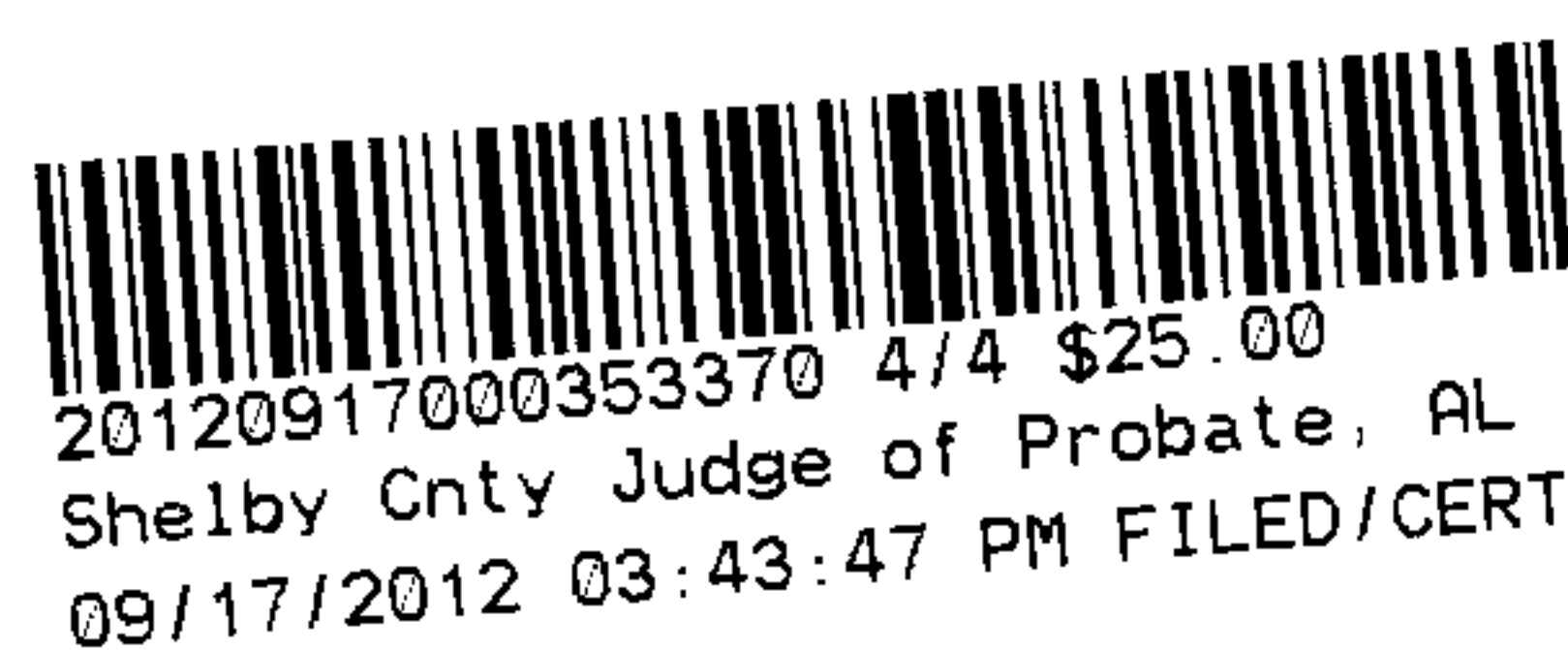
