KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of EIGHT HUNDRED NINETY TWO AND 00/100 (\$892.00) dollar(s), cash in hand paid to the undersigned by the Shelby County Highway Department, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), SUSAN P. WILDER WHITE, WHO IS THE SURVIVING GRANTEE OF DECEASED HUSBAND GEOFFREY M. WILDER have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto the State of Alabama the following described property:

A part of the Section 22, Township 22 South, Range 3 West, identified as Tract No. 1 on Project No ACBR58382-ATRP(001) in Shelby County, Alabama and being more fully described as follows:

Parcel 1 of 2:

Commencing at the Northeast corner of the SW 1/4 of Section 22, T-22-S, R 3-W,

Thence S 48°59'38" E a distance of 644.78 feet to a point on the acquired R/W line (said point offset LT. 65.00' and perpendicular to project centerline at station 9+00.00) which is the point of BEGINNING; thence N 54°49'36" E and along the acquired R/W line a distance of 117.27 feet to a point on the acquired R/W line, which is also the center of Dry Creek;

Thence S 75°45'56" E and along the center of said Dry Creek a distance of 33.24 feet to a point on the present R/W line of County Road 12 (80' R/W);

Thence S 54°50'31" W and along the present R/W line a distance of 138.90 feet to a point on the acquired R/W line (said point offset LT. 40' +/- and perpendicular to project centerline at station 9+00.00);

Thence N 35°10'24" W and along the acquired R/W line a distance of 25.20 feet; to the point and place of BEGINNING, containing 0.074 acres, more or less;

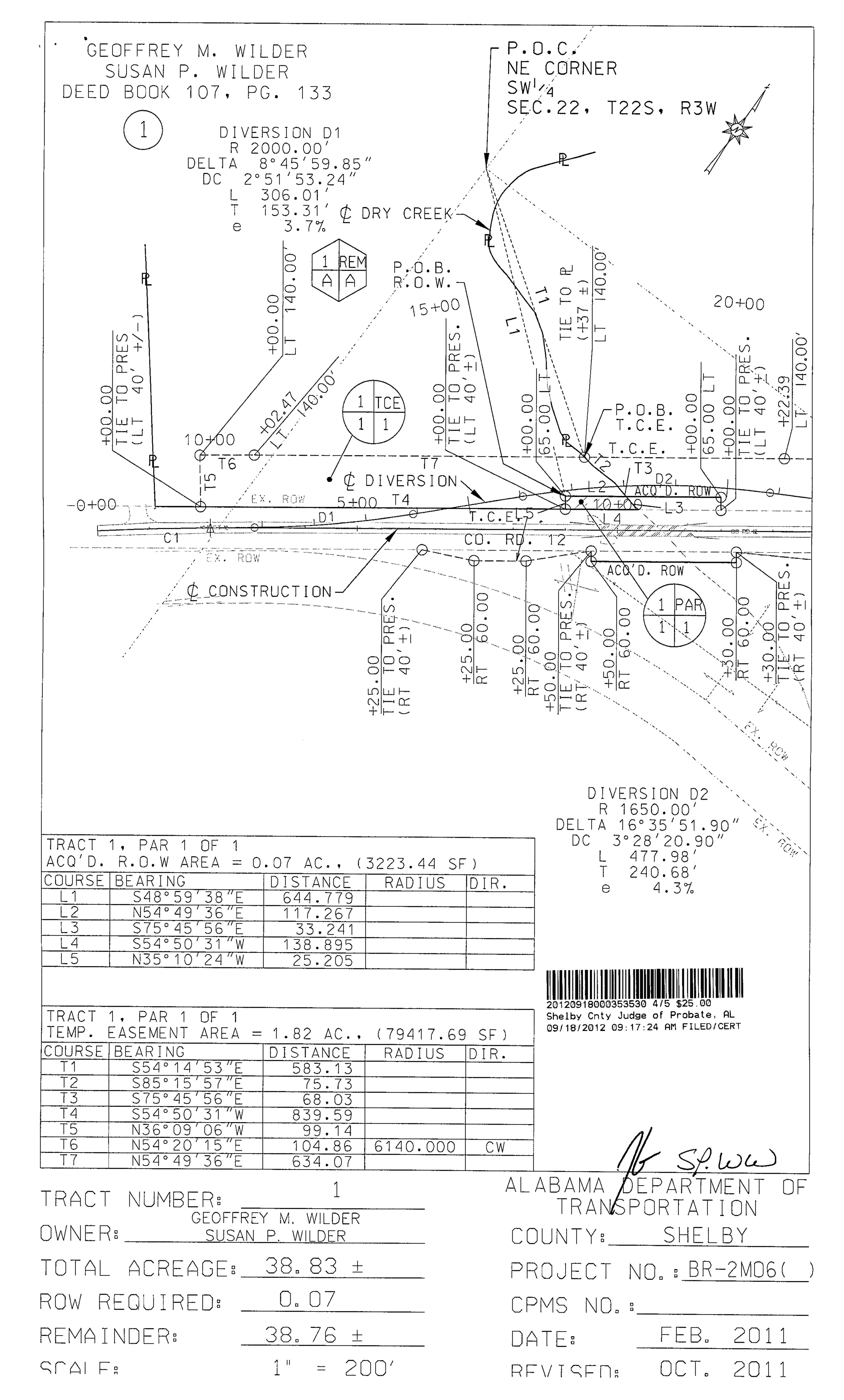
