That in consideration of **One Hundred Sixty-Four Thousand and 00/100 Dollars (\$164,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Siryvonne Bell and Davina Bell

(hereinafter referred to as "Grantee"), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

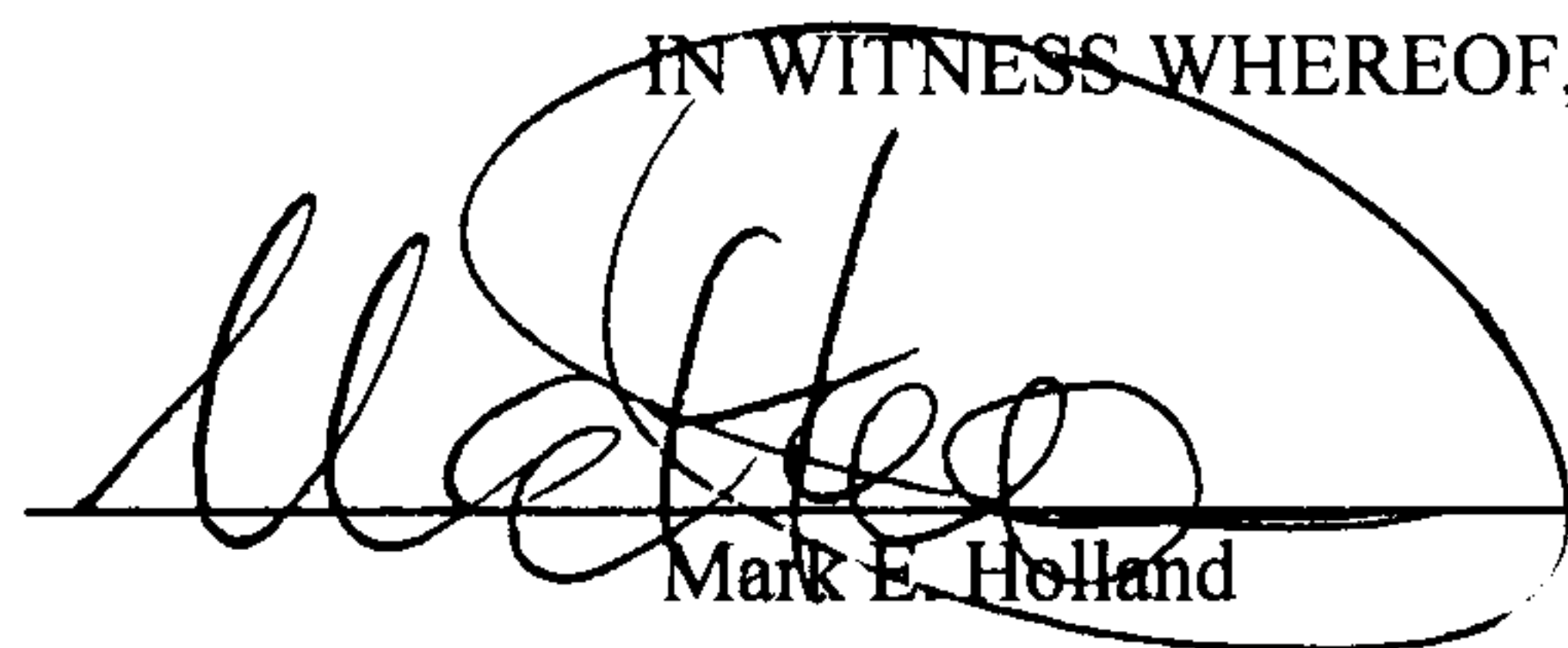
\$167,346.00 of the proceeds come from a purchase money mortgage recorded simultaneously herewith.

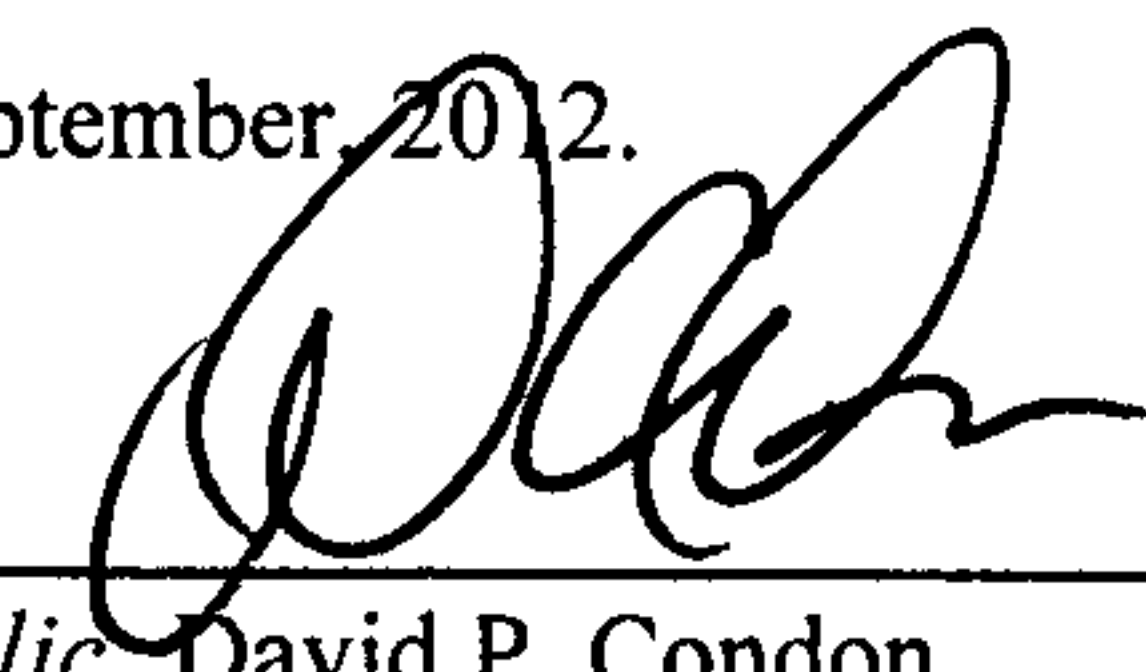
