Barbara Jean Steele has personal knowledge that Vincent Artle died prior to June 30th, 2003.

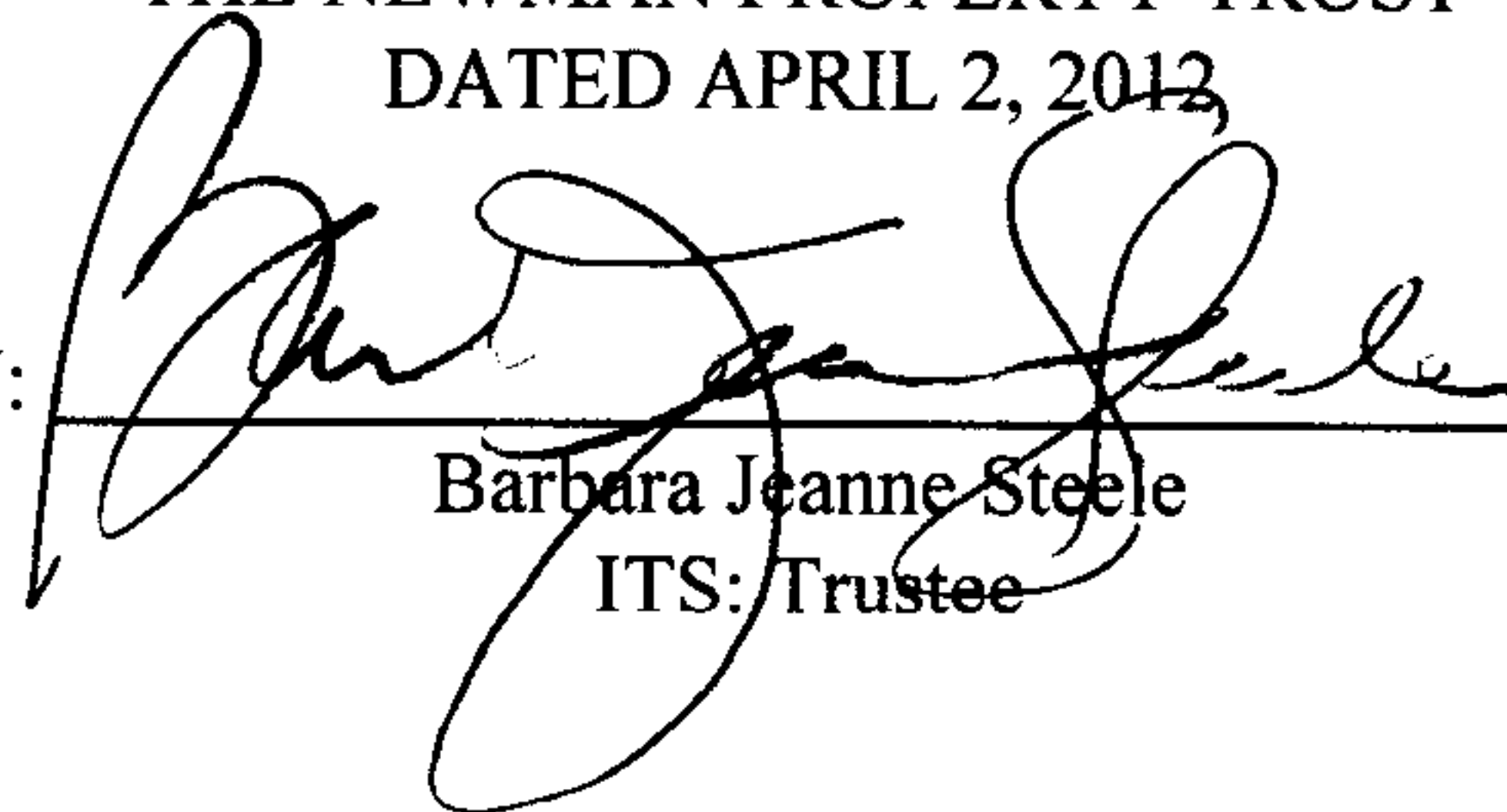
- Subject to:

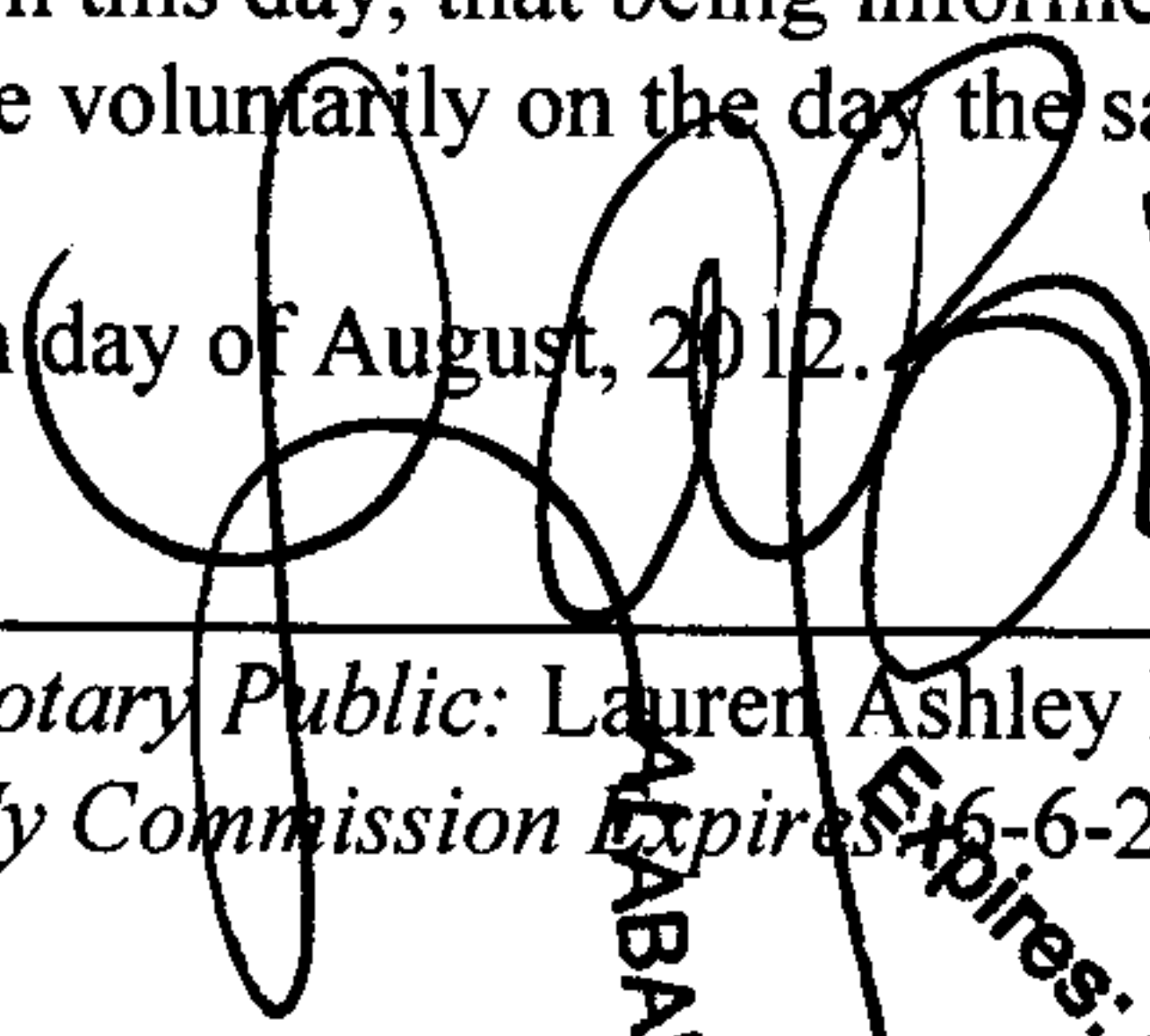
