FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of December, 2003, Paul B. Adamson, Jr. and Barbara E. Adamson, husband and wife, executed that certain mortgage on real property hereinafter described to McGowin-King Mortgage LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument 20031215000806050, said mortgage having subsequently been transferred and assigned to Chase Home Finance LLC, by instrument recorded in Instrument Number 20100526000167190, in the aforesaid Probate Office ("Transferee"); and

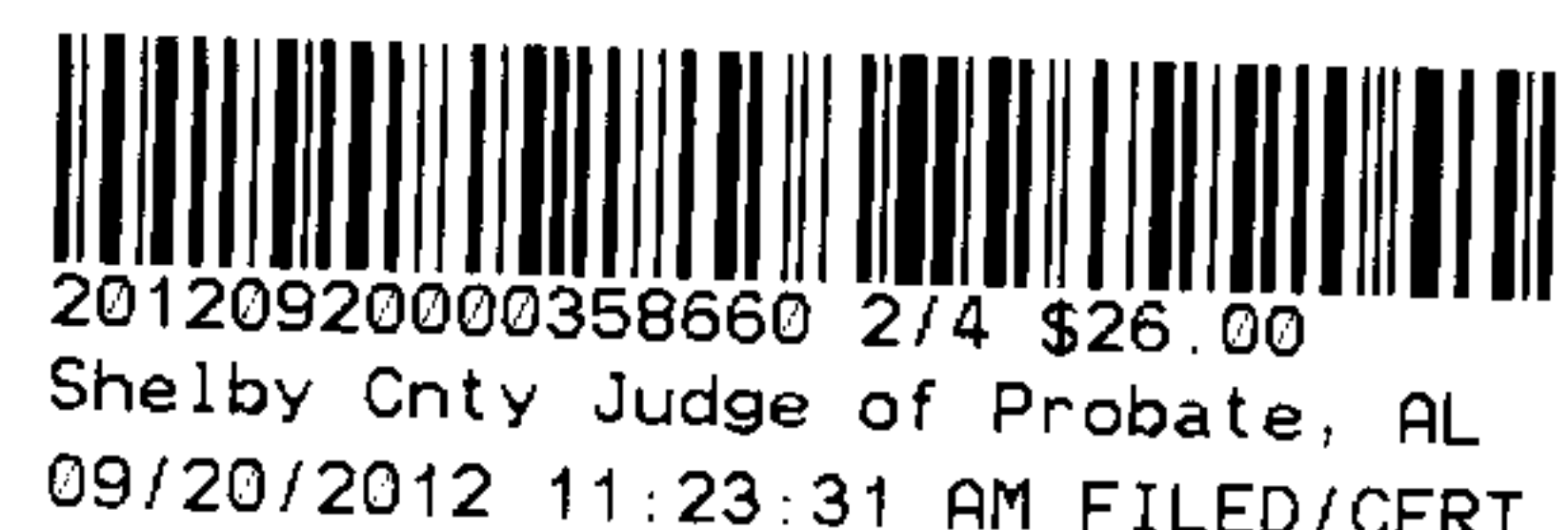


