KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of February, 2001, Fred M. Powell, Sr. and Sybil E. Powell, husband and wife, executed that certain mortgage on real property hereinafter described to New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2001-06303, said mortgage having subsequently been transferred and assigned to GMAC Mortgage Corporation, by instrument recorded in Instrument Number 2001-39560, in the aforesaid Probate Office ("Transferee"); and

Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of July 25, 2012, August 1, 2012, and August 8, 2012; and

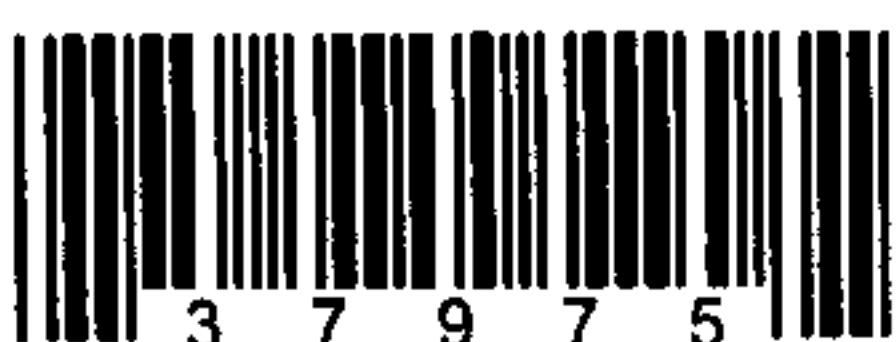


