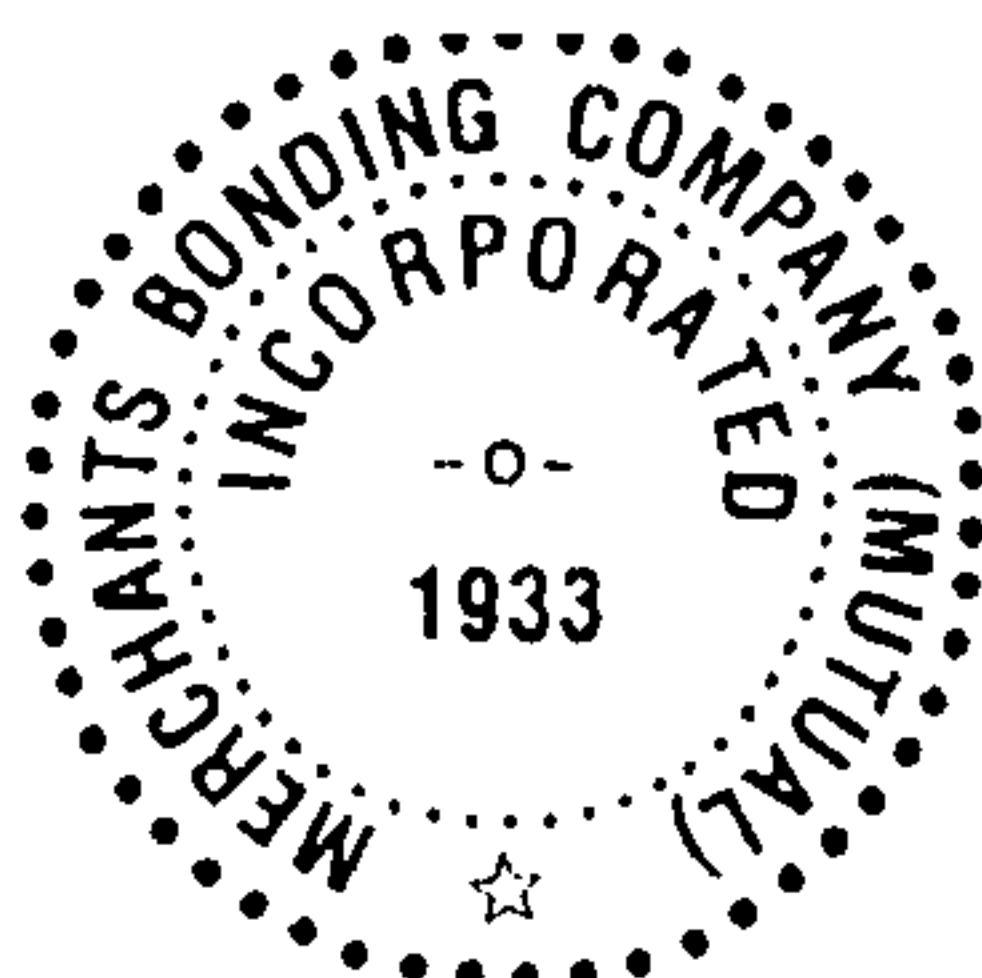





TWO HUNDRED THOUSAND (\$200,000.00) DOLLARS

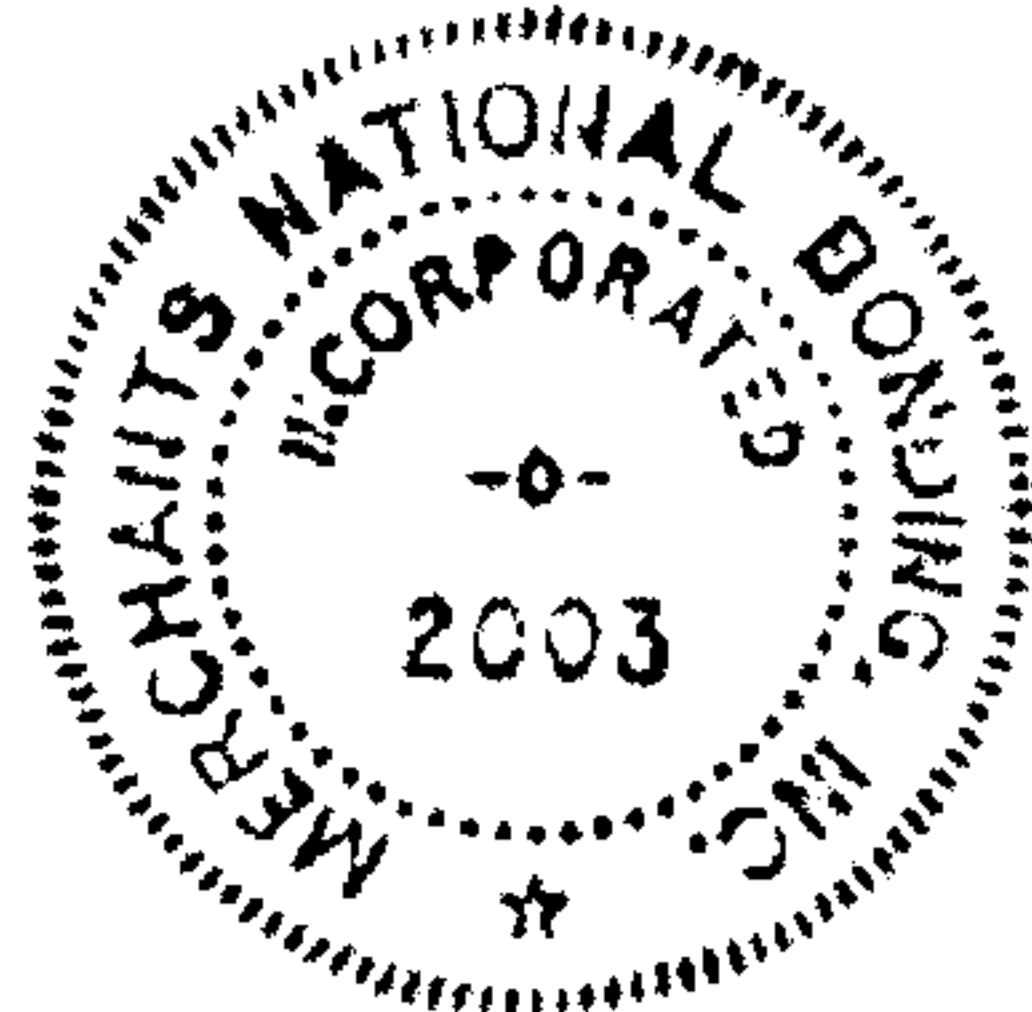
