

## FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on August 27, 2007, to-wit: Liliane Nublat, an unmarried person, executed a mortgage to Mortgage Electronic Systems, Inc., as nominee for Freedom Mortgage Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on September 20, 2007, in Instrument Number 20070920000442280, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, N.A., by assignment dated May 24, 2012, and recorded in Instrument Number 20120626000224830, Probate Records of Shelby County, Alabama; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on July 25, 2012, August 1, 2012, and August 8, 2012, that the hereinafter described property would be sold at the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on August 28, 2012, and
