WHEREAS, the said municipal governing body has ascertained and determined the result of said election as follows:



Pursuant to Section 17-10-A-2, Code of Alabama, the Board of Registrars shall determine whether or not each provisional ballot should be counted. In this municipal election, eight (8) provisional ballots were cast. The Shelby County Board of Registrars has determined that seven (7) provisional ballots should be counted and one (1) provisional ballot will not be counted.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pelham, Alabama, as follows:

1. That Gary W. Waters received a majority of the votes cast for the office of Mayor and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2012.
2. That Rick Hayes received a majority of the votes cast for the office of City Council Place 1 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2012.
3. That Ron Scott received a majority of the votes cast for the office of City Council Place 2 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2012.
4. That Beth McMillian received a majority of the votes cast for the office of City Council Place 3 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2012.
5. That no candidate received a majority of the votes cast for the office of City Council Place 4 and Maurice Mercer and Jim Phillips received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 9, 2012, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
6. That Karyl Rice received a majority of the votes cast for the office of City Council Place 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2012.


