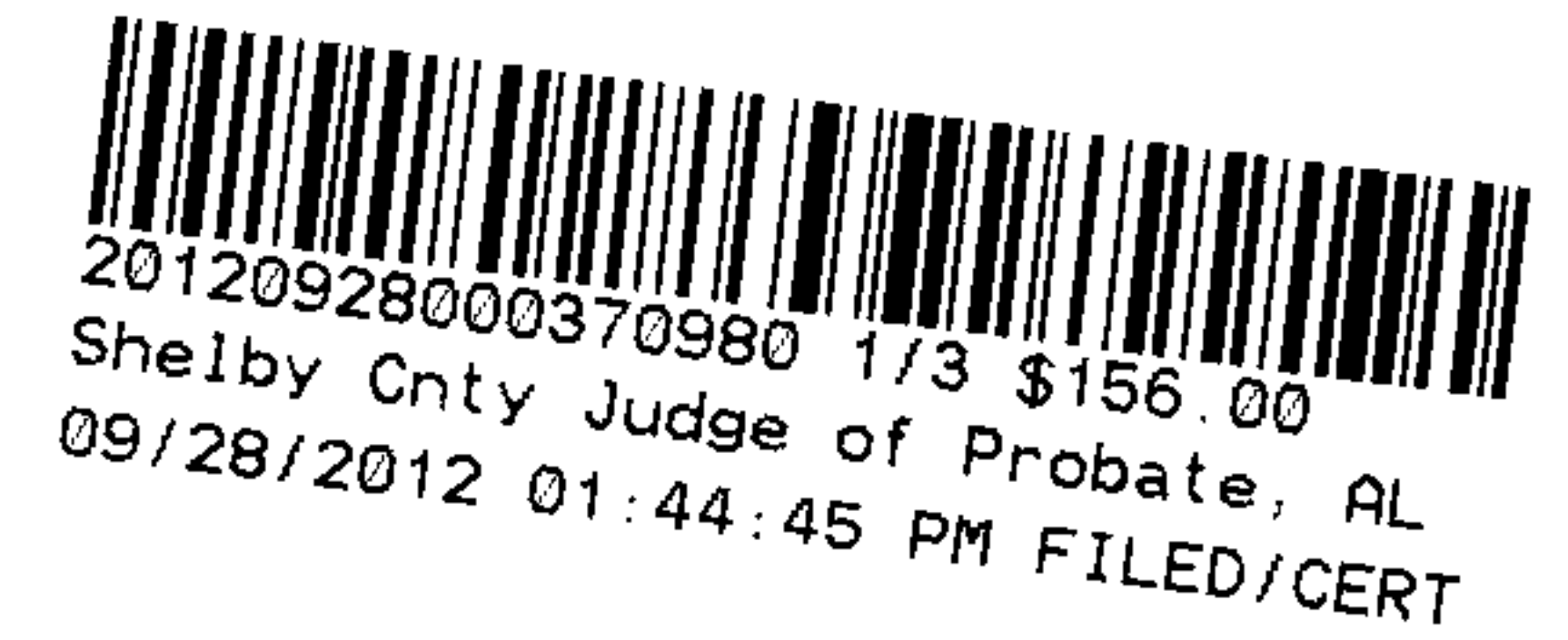


ARTICLES OF ORGANIZATION OF RETAIL SERVICES ALABAMA LLC



Pursuant to the Provisions of Sections 10-21-1 of the Code of Alabama (1975) as amended (the "Alabama Limited Liability Company Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE ONE

The name of the company shall be **RETAIL SERVICES ALABAMA LLC**

ARTICLE TWO

The period of duration shall be for a period of thirty-five (35) years, unless the Members agree to extend its duration or the Company is dissolved and its affairs wound in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The purpose for which the Company is formed is to engage in any lawful act or an activity of which limited liability companies may be organized pursuant to the Act.

ARTICLE FOUR

The location and street address of the initial registered office of the Company shall be 1401 Doug Baker Blvd., Suite 107 – 105, Birmingham, Alabama 35242, and its registered agent at such address shall be Charles Frusterio.

ARTICLE FIVE

The names and addresses of the initial members are:

ARTICLE SIX

Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms of their admission shall be set forth in the Company's Operating Agreement.


ARTICLE SEVEN

The Company may be reconstituted and the business of the Company may be continued following an event of dissociation which terminates the membership of a member of the Company if (1) there is at least one remaining member and (2) the business of the Company is continued by a written consent of all the remaining members within 90 days after the occurrence of the event of dissociation.

ARTICLE EIGHT

The Company shall be managed by its Members in accordance with the Act and as further set forth in the Company's Operating Agreement.

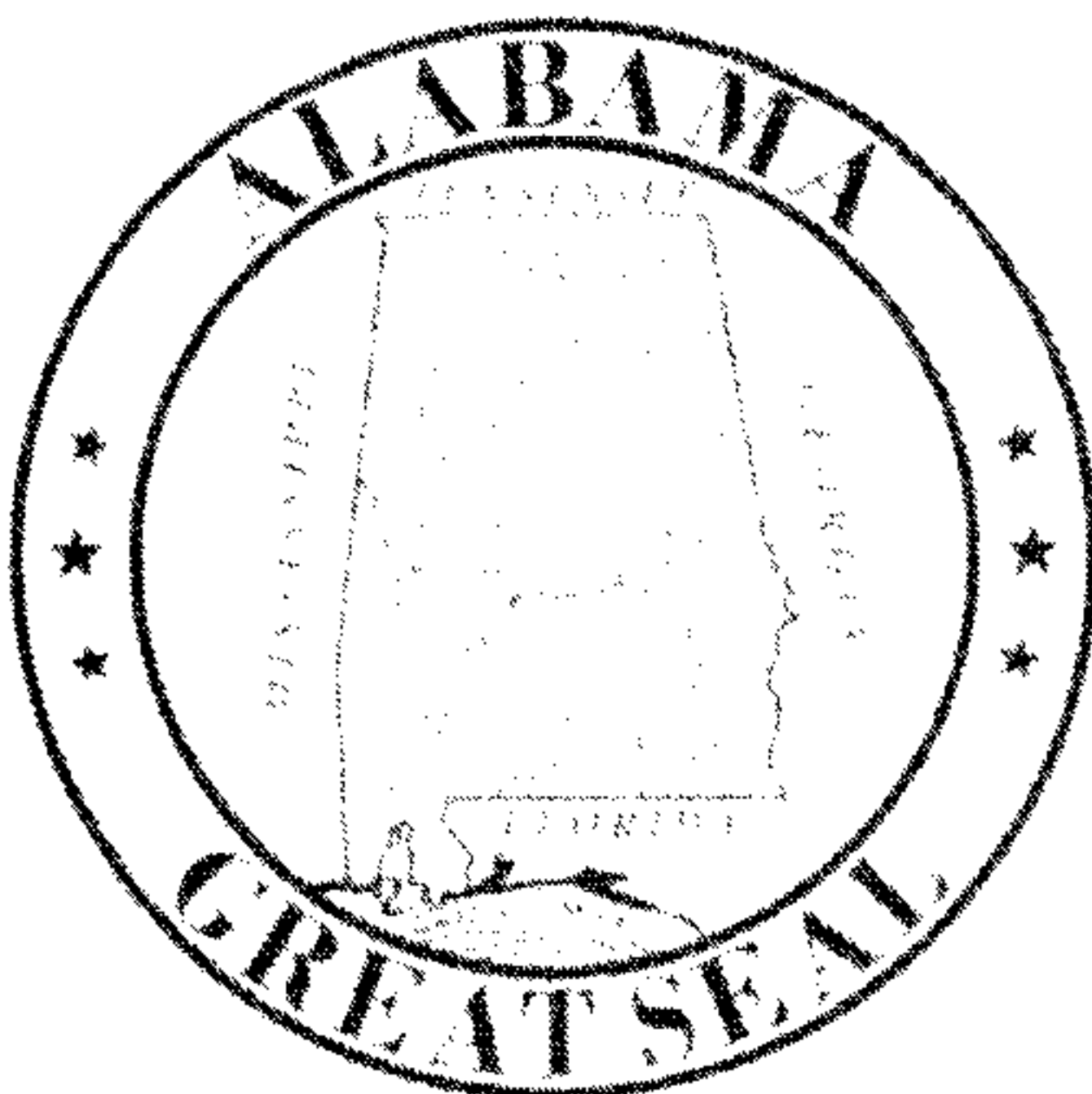
