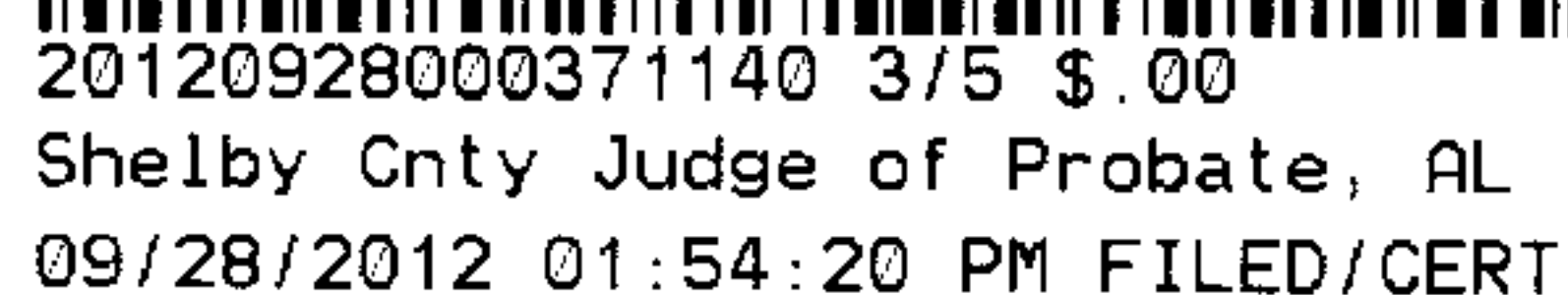


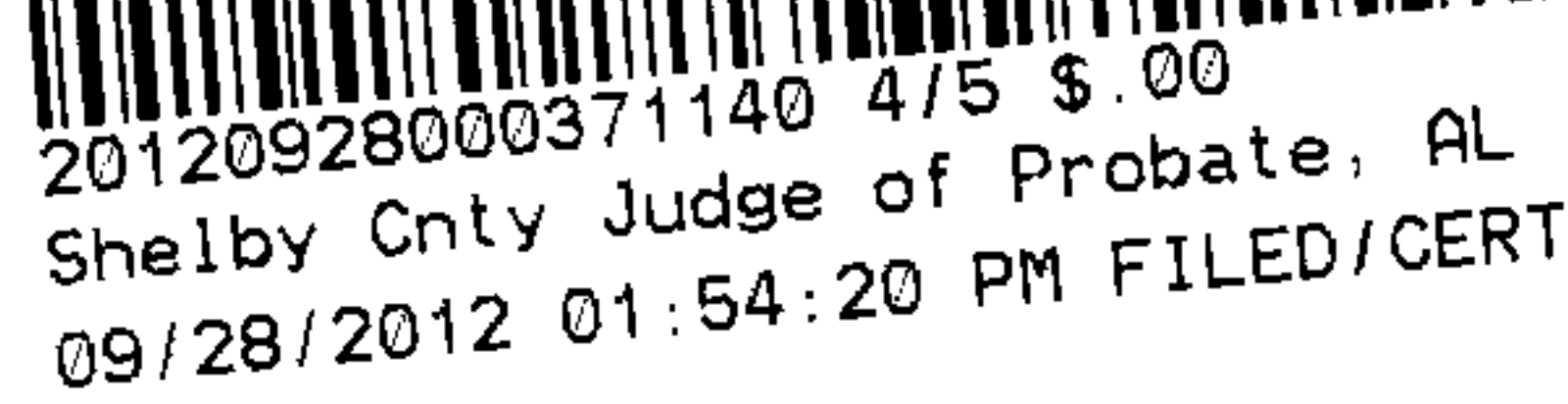
Figure 1. Distribution of respondents by age group.
