

ARTICLES OF ORGANIZATION OF BAFK Holdings, LLC An Alabama Limited Liability Company

Pursuant to the Provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is BAFK Holdings, LLC, an Alabama Limited Liability Company (the "Company").
