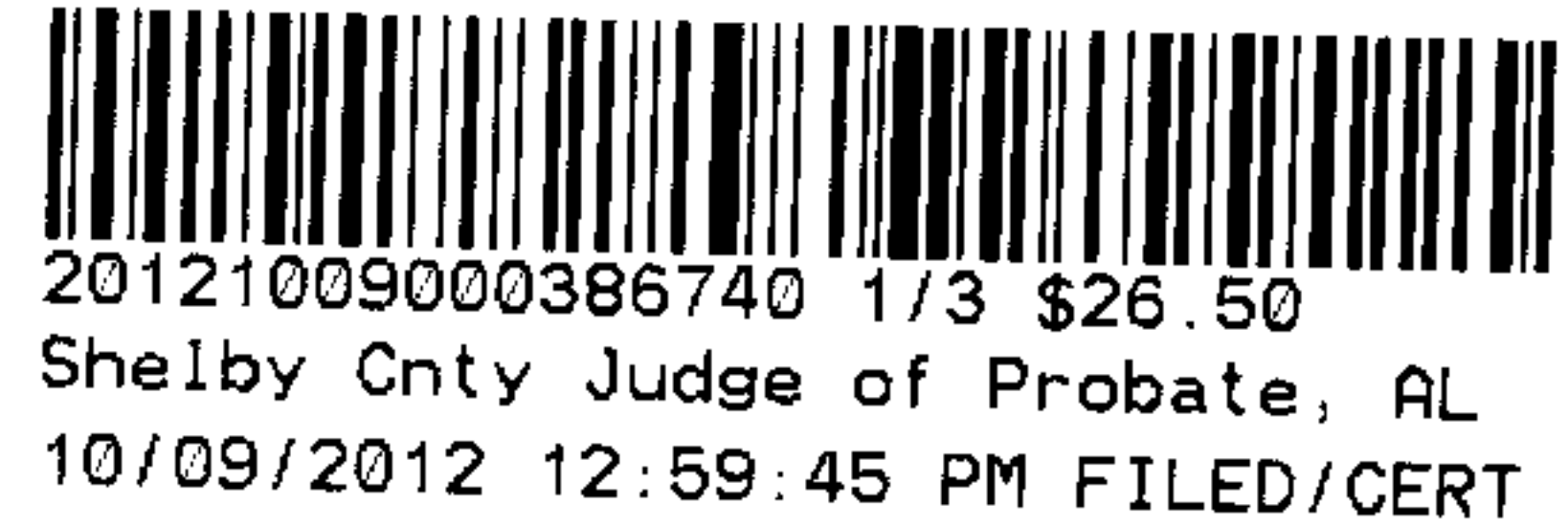

WARRANTY DEED



KNOW ALL MEN BY THESE PRESENTS:

That is consideration of One Hundred Sixty-One Thousand Six Hundred and 00/100 Dollars (\$161,600.00) in hand paid to the undersigned, ADAMS HOMES LLC (hereinafter referred to as "Grantor") by CHRISTOPHER D. 

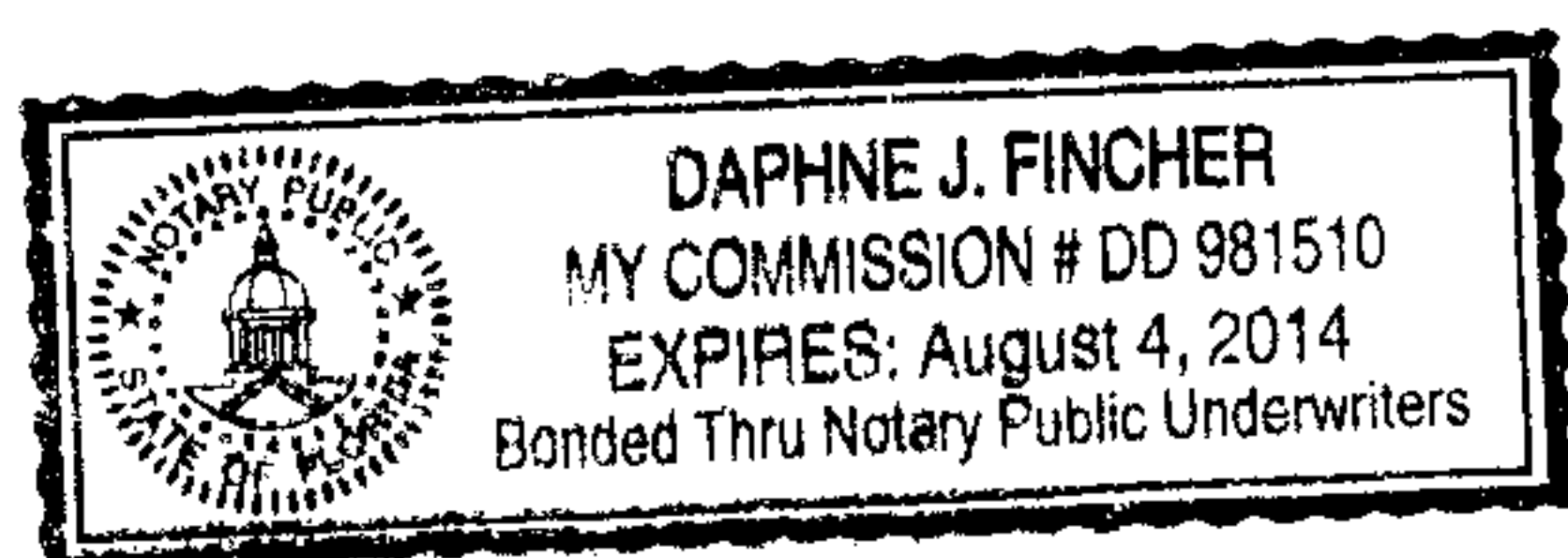


