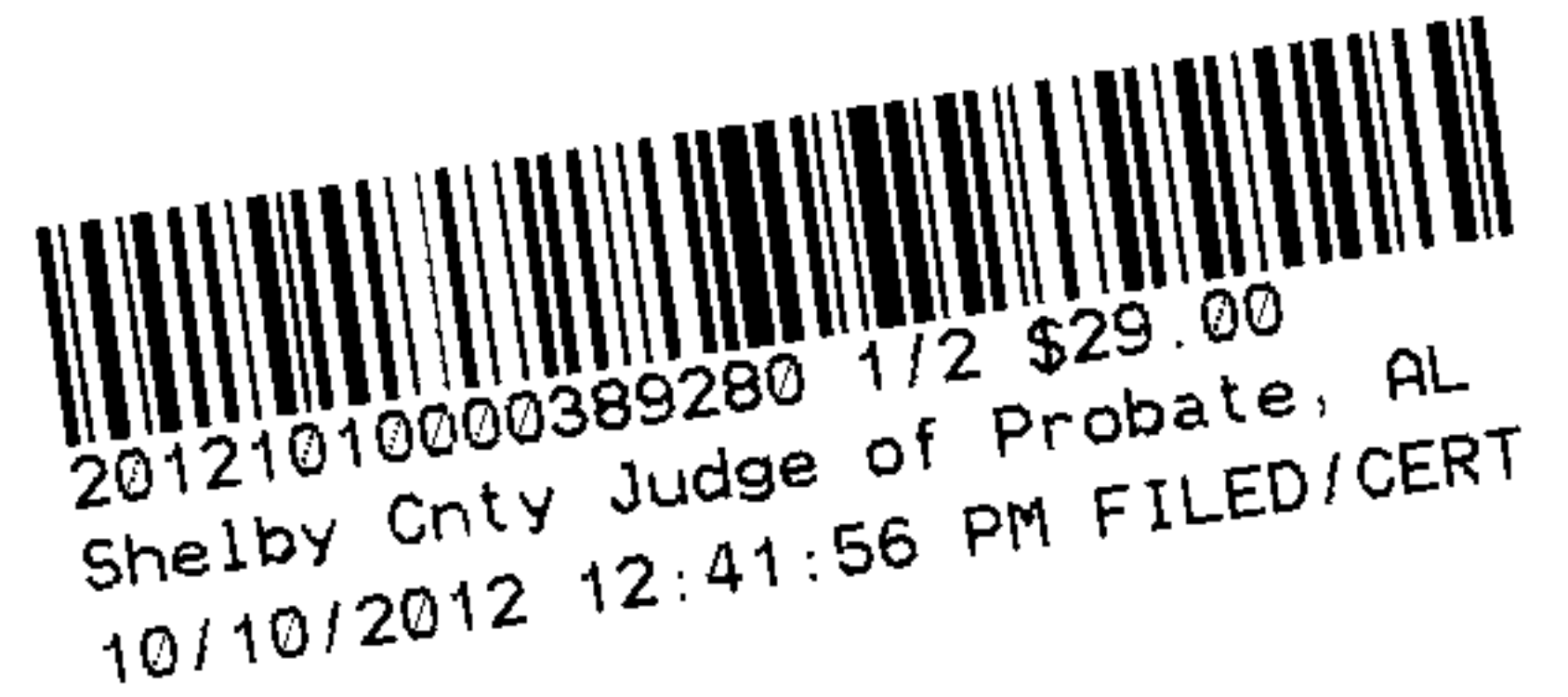


EXHIBIT A
