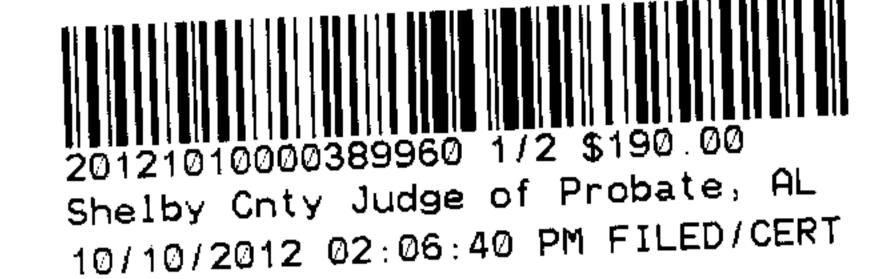

WARRANTY DEED
