KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Seventy Five Thousand and No/100 Dollars (\$175,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I, Rebecca A. Burbank, Assistant Vice President for Synovus Bank, (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Paul D. Borden and Brenda B. Borden, (hereinafter Grantee), as joint tenants with rights of survivorship, all of our right, title and interest in the following described real estate, situated in Jefferson County, Alabama.

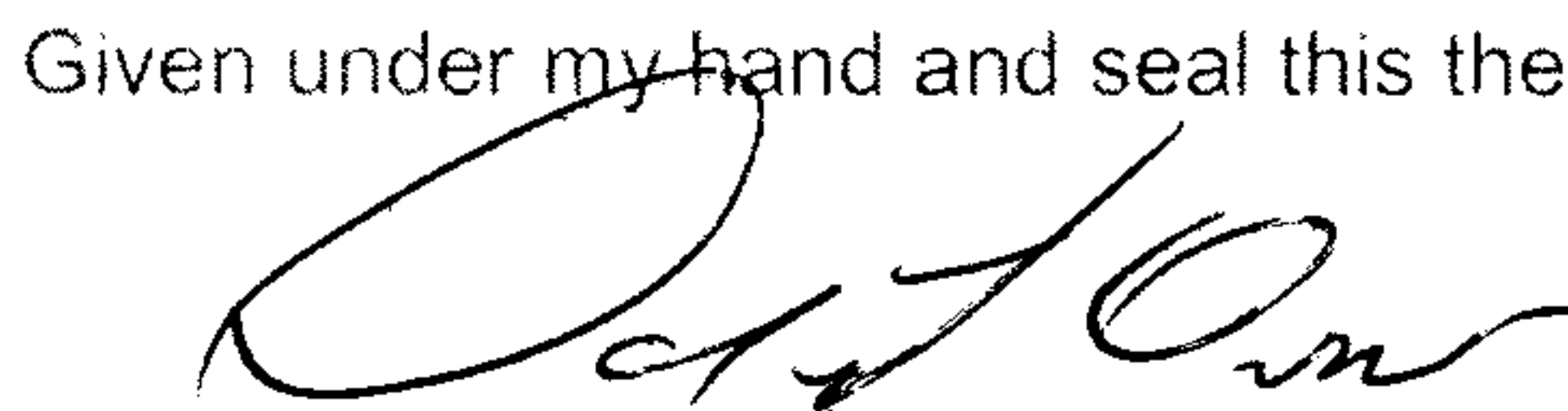

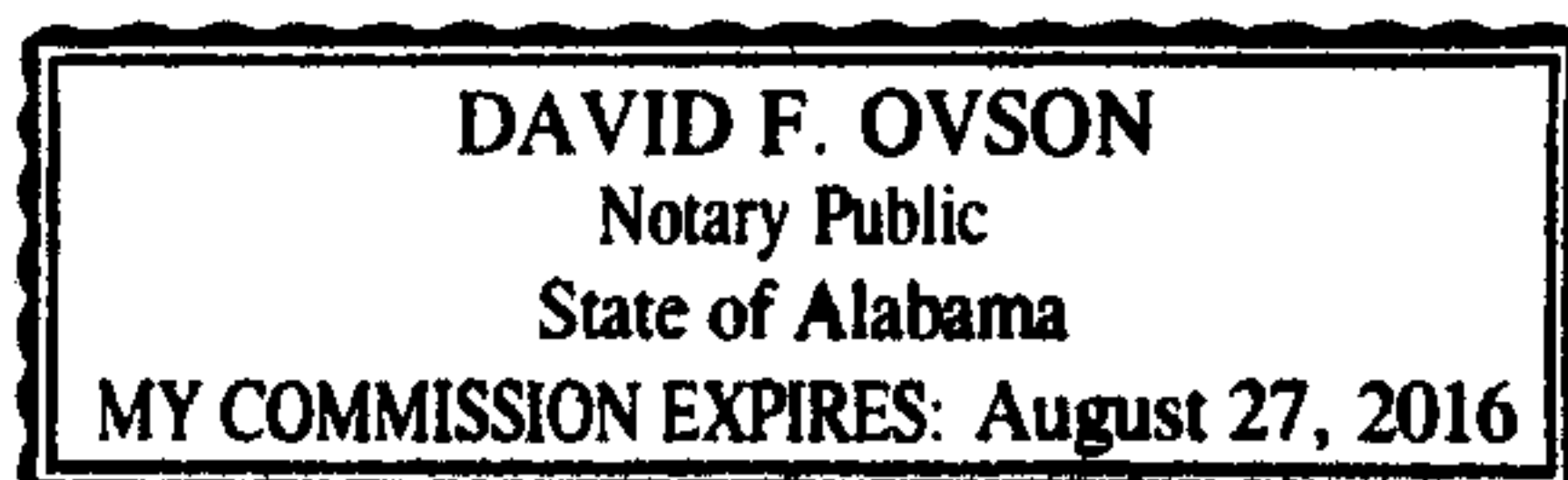
