**ARTICLES OF ORGANIZATION
OF
NO LIMITS TRUCKING, LLC**

The undersigned, desiring to form a limited liability company under the laws of the State of Alabama, do hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company shall be **No Limits Trucking, LLC** (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The term for which the Company is to exist as a limited liability company shall commence on the date these Articles of Organization are filed, and shall continue in perpetual existence or until the Company shall be dissolved (a) upon the written consent of all members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act, as amended from time to time (the "Act").

**ARTICLE III
PURPOSE**

The Company is formed to transact any and all lawful business for which a limited liability company may be organized under the Act, including, but not limited to acquiring, owning, operating or managing a trucking business and to engage in any and all activities related or incidental to the business of the Company.

**ARTICLE IV
LOCATION OF REGISTERED OFFICE AND NAME OF REGISTERED AGENT**

The initial registered office of the Company shall be at 200 Farmingdale Trace, Harpersville, AL 35078, and the name of the initial registered agent at such address shall be Robby Collins. The Principal place of business of the Company shall be at 200 Farmingdale Trace, Harpersville, AL 35078.

**ARTICLE V
MEMBERS**

The names of the initial Members of the Company are Robby Collins, Willie Allen and James Torbert. The address of the initial Members of the Company is set forth in the Operating Agreement of the Company.

ARTIVLE VII ADDITIONAL MEMBERS

The Members reserve the right to admit additional members upon the unanimous agreement of the Members as to the admission of, and the consideration to be paid by, such new member or members, and subject to the terms and conditions of the Company's Operating Agreement.

ARTICLE VIII OPERATING AGREEMENT

The Operating Agreement of the Company shall be executed by each Member of the Company and shall set forth all provisions for the affairs of the Company and the conduct of its business to the extent that such provisions are not inconsistent with the law or these Articles of Organization.

ARTICLE IX CONTINUATION UPON WITHDRAWAL OF MEMBER

The existence of the Company shall continue upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any event which terminates the continued membership of a Member in the Company (collectively, "Cessation"), as long as, after the Cessation of the last Member, one or more new Members are admitted, as set forth in the Operating Agreement of the Company.

ARTICLE X LIABILITIES OF MEMBERS AND MANAGERS

Members and Managers of the Company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the Company. The Company does indemnify its Members and Managers as set forth in the Operating Agreement.
