

AUCTIONEER'S DEED

WHEREAS, JOHN G. MAYER and KAREN MAYER, husband and wife executed a mortgage to Mortgage Electronic Registration Systems, Inc. (MERS) acting solely as nominee for Lender, Countrywide Home Loans, Inc., and Lender's Successors and Assigns on the 20th day of September, 2005 on that certain real property hereinafter described, which mortgage is recorded in Instrument No. 20050921000488920, of the records in the Office of the Judge of Probate, Shelby County, Alabama; which said mortgage was subsequently assigned to BAC Home Loans Servicing, LP n/k/a Bank of America, N.A. successor by merger to BAC Home Loans Servicing, LP f/k/a Countrywide Home Loans Servicing, LP by instrument recorded in Instrument No. 20110413000114220 of said Probate Court records; and
