

## ARTICLES OF ORGANIZATION OF TBG ENTERPRISES, LLC



The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certifies as follows:

- 1. Name. The name of the entity is TBG Enterprises, LLC.
- 2. Type of Entity. The type of entity being formed is a limited liability company.
- 3. <u>Purpose</u>. The purposes for which this limited liability company is organized are to purchase, hold, sell, improve and lease real property and mortgage and encumber the same and to erect, manage, care for and maintain, extend and alter buildings thereon, and to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
- 4. <u>Duration</u>. The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Law.
- 5. Registered Agent and Registered Office. The location and mailing address of the initial registered office shall be 1009 Ridge Circle, Birmingham, Alabama 35242, and the name of the initial registered agent at said address shall be William David Brogdon.
- 6. <u>Initial Member</u>. The name of the initial member of the limited liability company is William David Brogdon, and the address of the initial member is 1009 Ridge Circle, Birmingham, Alabama 35242.
- 7. Admission of Additional Members. The members of the limited liability company shall have the right to admit additional members to the limited liability company, as provided in the Operating Agreement.
- 8. Managed by Members. The limited liability company shall be managed by its members.


