KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of October, 2005, Teresa Stahl, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051014000537750, said mortgage having subsequently been transferred and assigned to Chase Home Finance, LLC, by instrument recorded in Instrument Number 20101025000356140, in the aforesaid Probate Office ("Transferee"); and
