KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of September, 2007, Letessia F. Bush and Johnny M. 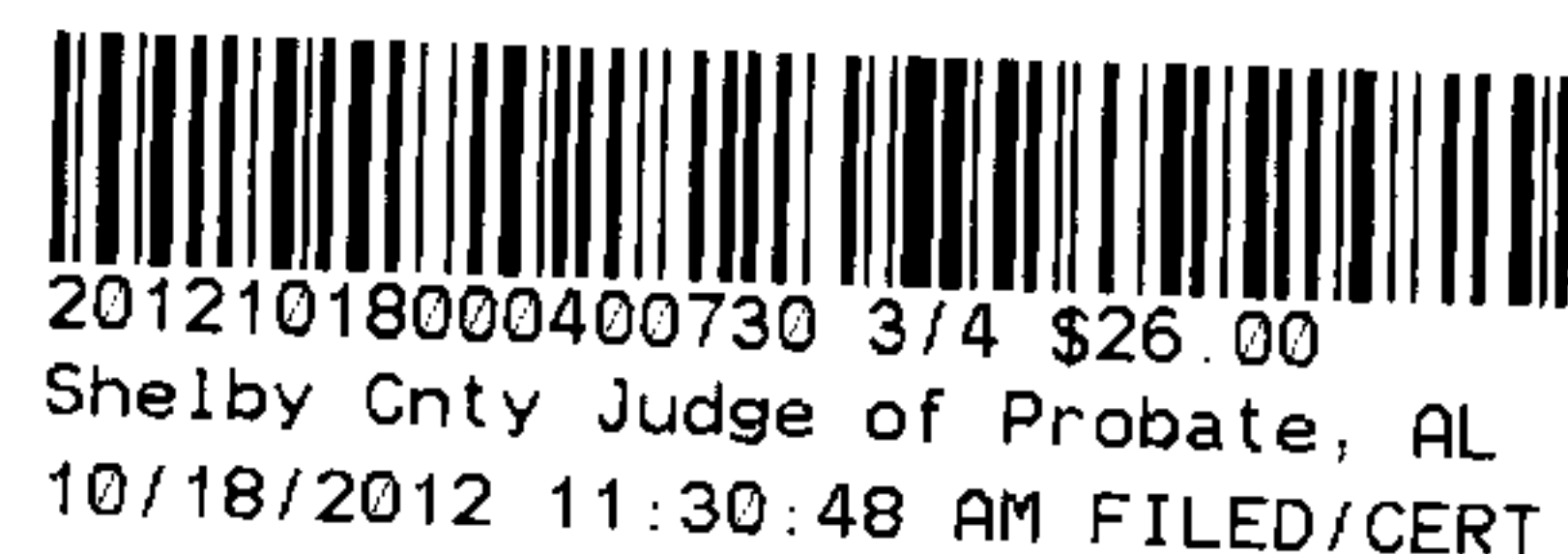
