FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on May 12, 2008, to-wit: Terry C. Parker Jr., An Unmarried Person, executed a mortgage to First American Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on May 14, 2008, in 20080514000196710, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded May 21, 2008, and recorded in 20080521000206780, Probate Records of Shelby County, Alabama; and
