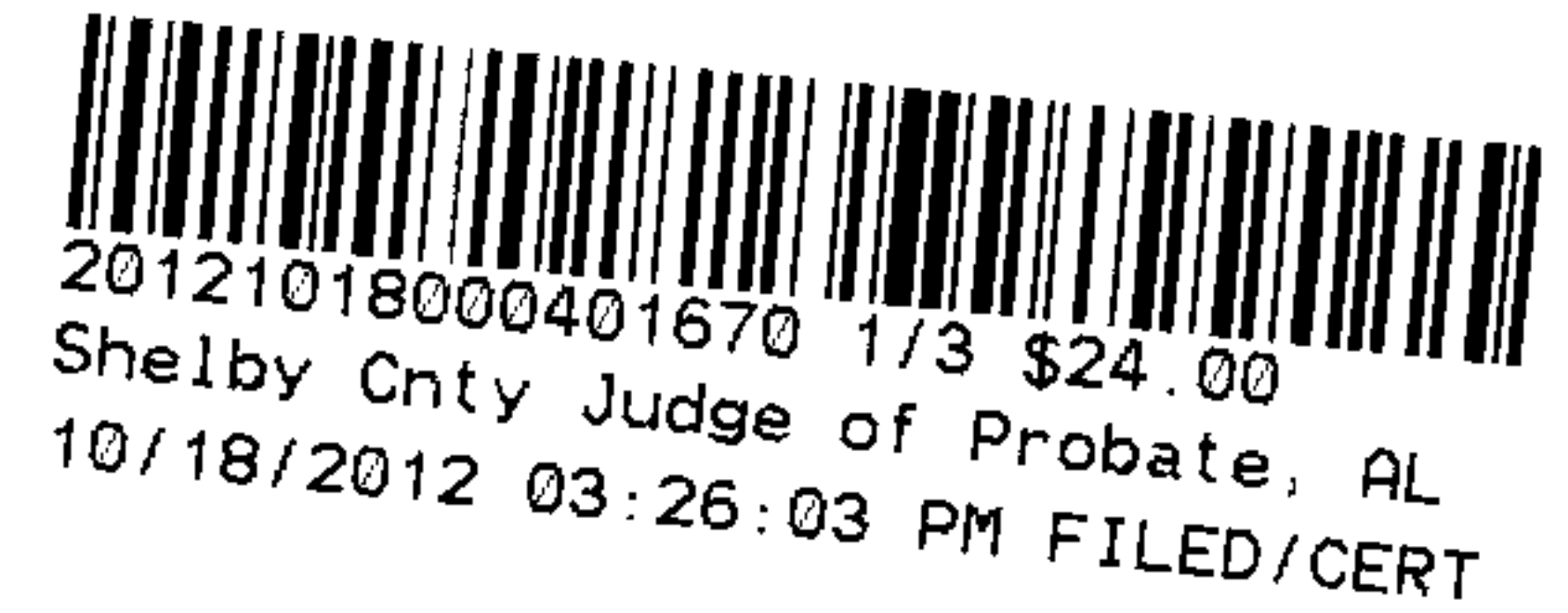


AUCTIONEER'S DEED

WHEREAS, THY NGUYEN, a single woman executed a mortgage to Mortgage Electronic Registration Systems, Inc. (MERS) acting solely as nominee for Lender, First Federal Bank, and Lender's Successors and Assigns on the 4th day of June, 2010 on that certain real property hereinafter described, which mortgage is recorded in Instrument No. 20100622000197580, of the records in the Office of the Judge of Probate, Shelby County, Alabama; which said mortgage was subsequently assigned to Bank of America, N.A., as successor by merger to BAC Home Loans Servicing, LP f/k/a Countrywide Home Loans Servicing, LP by instrument recorded in Instrument No. 20110617000178960 of said Probate Court records; and
