

## AUCTIONEER'S DEED

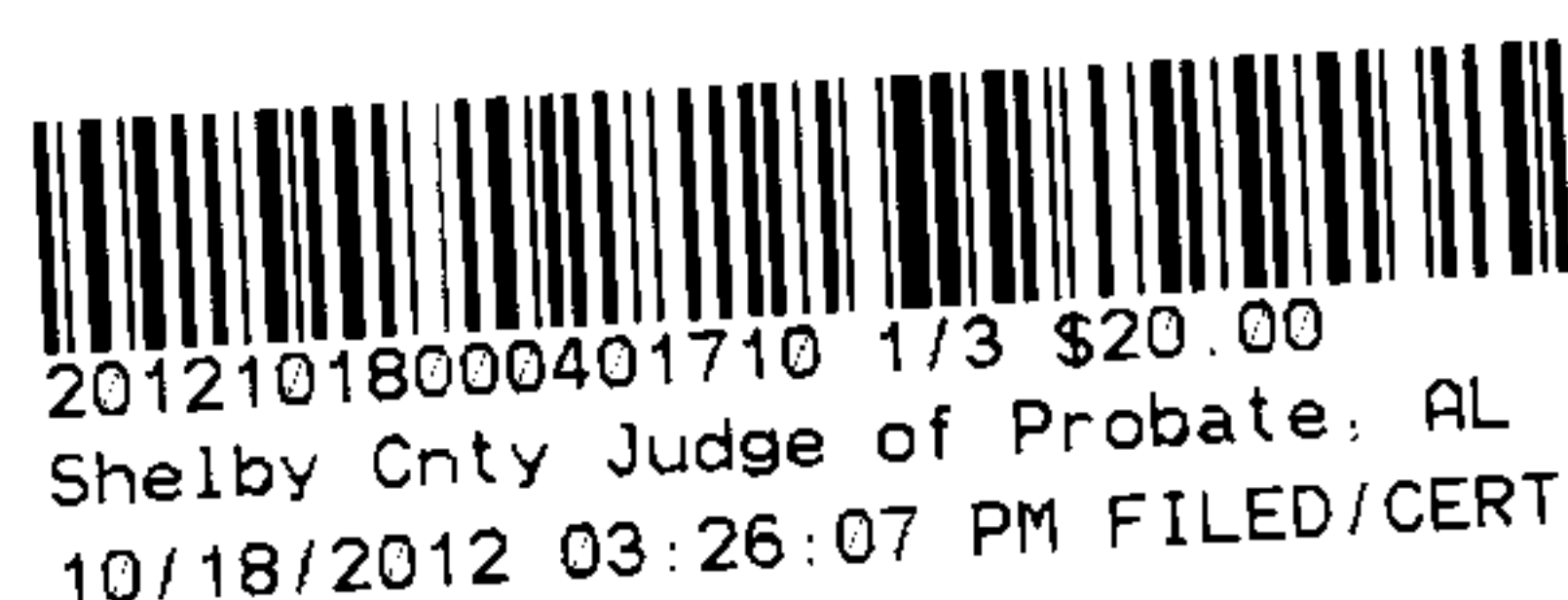


