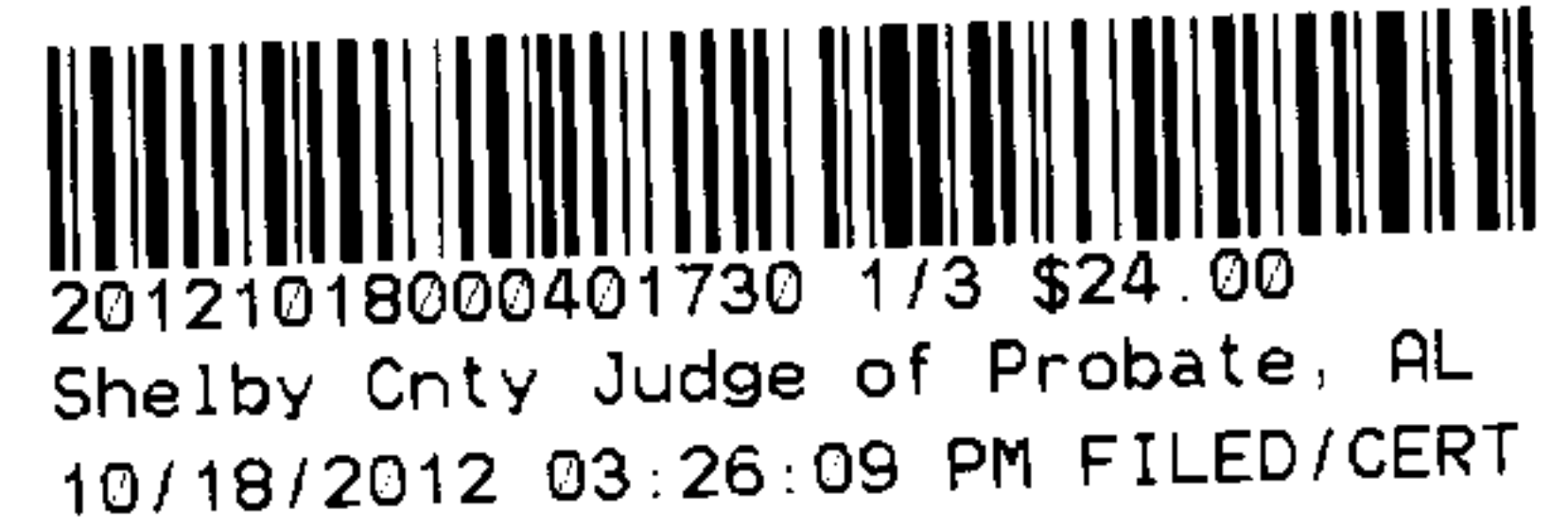


AUCTIONEER'S DEED

WHEREAS, BRETT A. TRAYWICK and CARMEN D. TRAYWICK, Husband and Wife executed a mortgage to Mortgage Electronic Registration Systems, Inc. (MERS) acting solely as nominee for Lender, Bank of America, N.A., and Lender's Successors and Assigns on the 9th day of July, 2009 on that certain real property hereinafter described, which mortgage is recorded in Instrument No. 20090720000278810, of the records in the Office of the Judge of Probate, Shelby County, Alabama; which said mortgage was subsequently assigned to Bank of America, N.A., successor by merger to BAC Home Loans Servicing, LP f/k/a Countrywide Home Loans Servicing, LP by instrument recorded in Instrument No. 20111017000309090 of said Probate Court records; and




