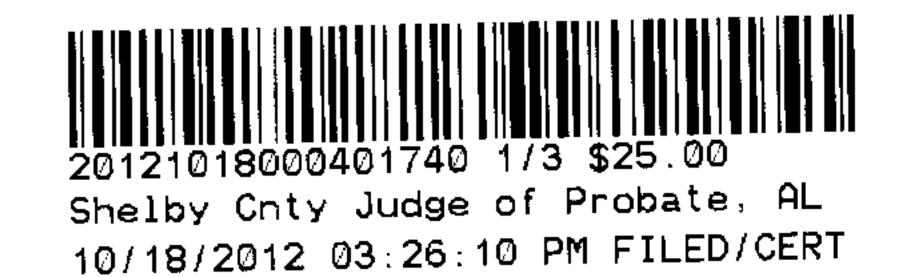
AUCTIONEER'S DEED



STATE OF ALABAMA COUNTY OF SHELBY

WHEREAS, CHARLES LEIGHTON ALLEN and PAULA V. ALLEN, Husband and Wife executed a mortgage to Mortgage Electronic Registration Systems, Inc.
