KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Sixty Nine Thousand Nine Hundred And No/100 Dollars (\$169,900.00) paid by the grantee herein, the receipt of which is hereby acknowledged, We, Roger C. Read and Christi C. Read, husband and wife, (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Joseph B. Pendry and Rhonda N. Pendry (hereinafter Grantees), as joint tenants with rights of survivorship, all of our right, title and interest in the following described real estate, situated in Shelby County, Alabama.


