

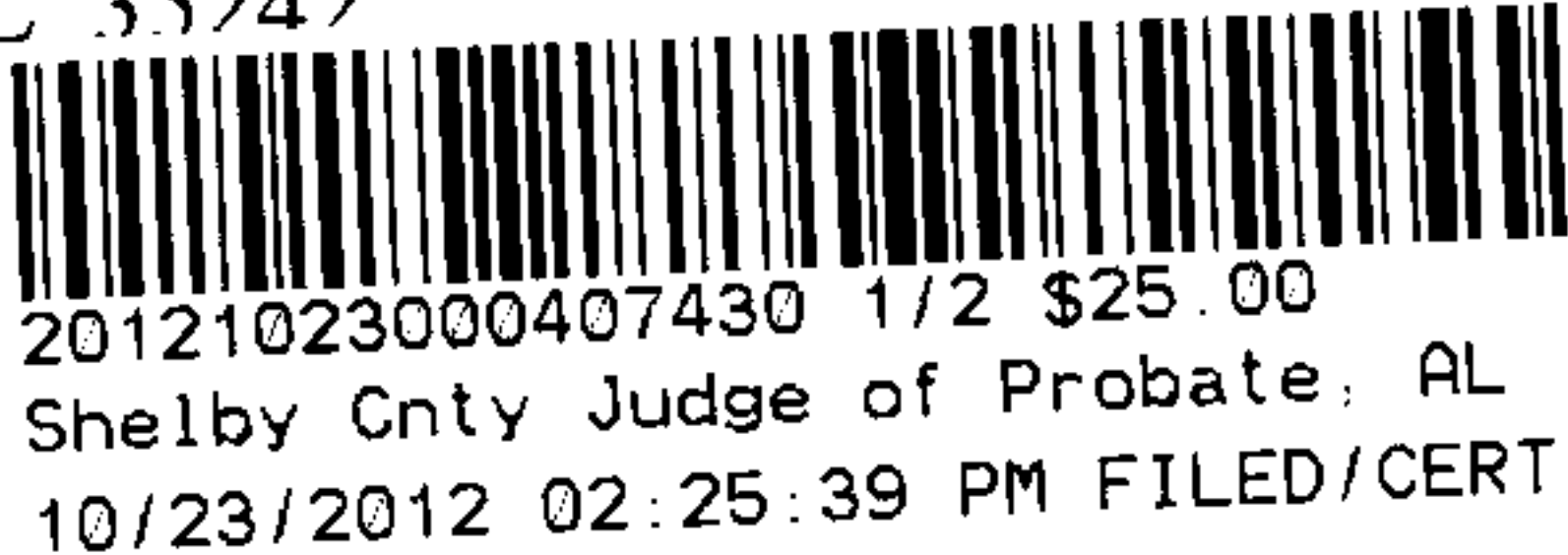

THOMAS DRYDEN AND DONNA DRYDEN, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE DRYDEN LIVING TRUST, DATED MARCH 12, 2012 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

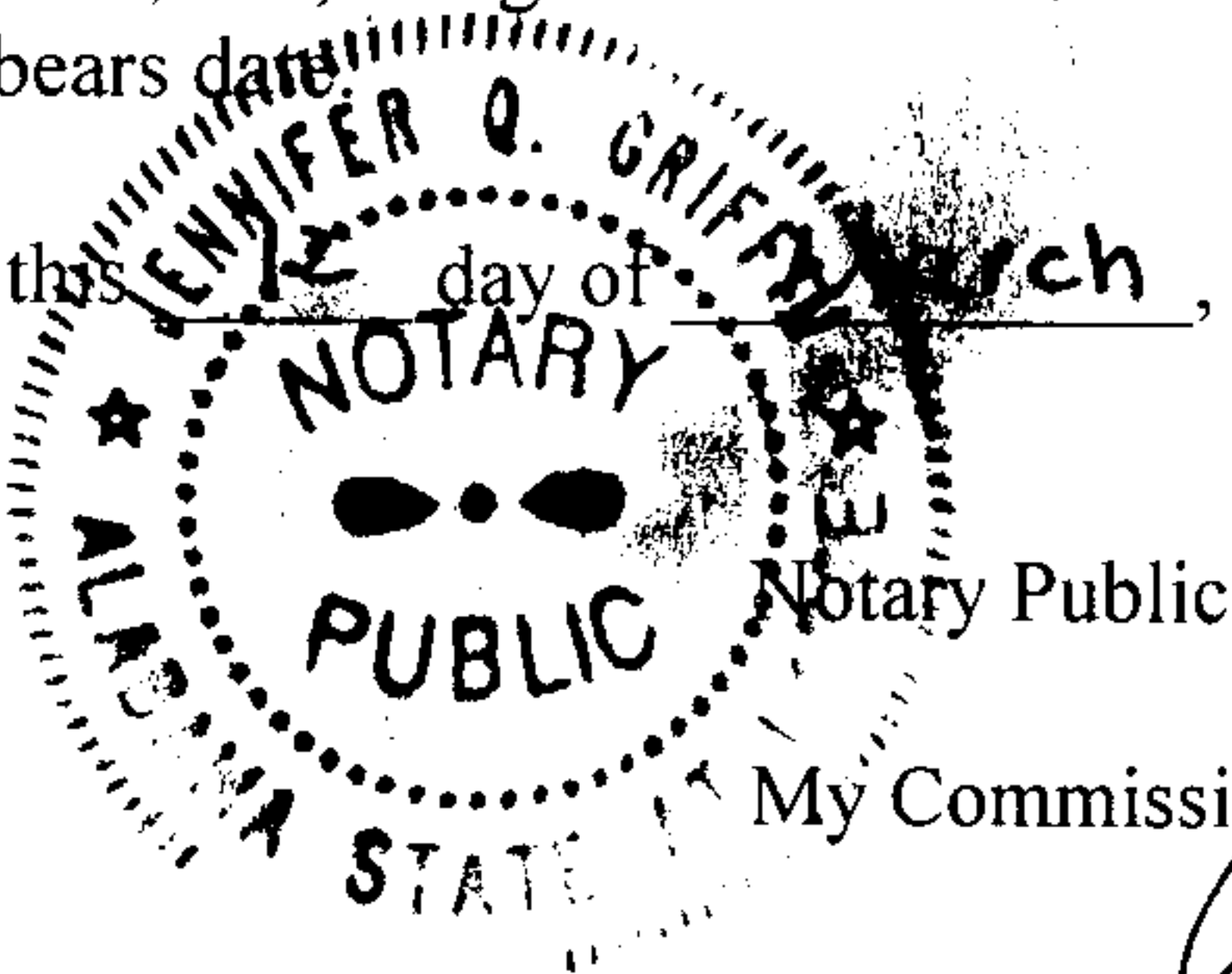
