KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of October, 2008, Josselyn P. Johnson and Jonas D. Johnson, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20081104000426240; having been modified by Loan Modification Agreement recorded in Instrument Number 20111205000366040, said mortgage having subsequently been transferred and assigned to Bank of America, N.A., successor by merger to BAC Home Loans Servicing, L.P. f/k/a Countrywide Home Loans Servicing, L.P., by instrument recorded in Instrument Number 20111110000339390, in the aforesaid Probate Office ("Transferee"); and


